Hillary Clinton Vs. Donald Trump and the Future of America

Never – or at least not in any living American's lifetime – has there been a presidential election like this one. In a shocking, stunning development, Donald J. Trump won the U.S. presidential election over Hillary Clinton! What does this mean for the future direction of the United States of America, and the whole world? What does Bible prophecy say about this?

Donald Trump has stunned the world and won the 2016 presidential election, according to multiple outlets. He will become the 45th president of the United States.

In a stinging rebuke to the ruling class, Trump harnessed the populist energy of his followers to issue a clear message to the Washington D.C. establishment. There's no denying that the people have demanded change; now it's up to Trump to deliver on his campaign promises.

Almost every major poll turned out to be useless as the Republican nominee pulled off a series of shocking upset victories in battleground states, including Florida, Ohio and North Carolina. Trump also became the first Republican to win Wisconsin since Ronald Reagan in 1984.

Hillary Clinton and her campaign were left shellshocked as they watched the election results come in. Some of the Democratic nominee's supporters were even seen crying at Clinton HQ in New York City.

There had been warnings that Trump could pull off a shocking upset; signs that went largely ignored by the media and political elites. The signs that voter enthusiasm was on Trump's side were certainly evident: Massive turnout at rallies.

Though his candidacy was mocked almost the entire way by critics, President Donald Trump has nonetheless become reality. The election result seems to be nothing less than a miracle – a heaven-sent blessing and gift of grace for the American people.

The Stunning Phenomenon

Like two powerful heavenly bodies – the vast Clinton machine and the unpredictable but brilliant Trump campaign – squared off against each other in the most important presidential election of all American history.

The result?

A stunning, shocking victory for Donald Trump who seeks to “make America great again”!

Aligned with Hillary and Bill Clinton was Barack Obama and the Democratic Party, now so radical as to be further left than many of the Western world's socialist governments – all of them failing, or worse. Also aligned with the Clintons were not only virtually the entire “mainstream media,” but also academia and Hollywood – what filmmaker Dinesh D'Souza calls society's “three big megaphones.”

But there's more: Essentially the entire financial and banking sector (“Wall Street”) sided with Clinton, as did the globalist elite, including corporate interests that, in pursuit of cheap labor, favor open borders, amnesty and one-sided “free trade” agreements, regardless of their negative impact on American jobs and workers. Same with the worldwide “climate-change” movement dedicated to massive taxation, global wealth redistribution and unprecedented power-grabbing on the pretext of saving the planet. Even some Republicans, a few openly but many more secretly, support returning the Clintons to the White House.

In short, the entire establishment elite, both national and global, lined up behind Hillary Clinton. And yet, who is this woman? Repeated polls show most Americans, including even many of her Democratic supporters, agree she is not only untrustworthy and dishonest (67 percent of voters), but a *criminal* (56 percent of voters). Indeed, many consider Hillary Clinton the *most corrupt candidate ever to run for U.S. president* on a major-party ticket.

But what about her widely touted “experience”? As Obama's first-term secretary of state, Clinton played a leading role in basically setting the world on fire – in some cases literally – through spectacularly inept and reckless leadership.

Then there is Donald Trump, the billionaire New York businessman, entrepreneur and first-time politician, outspoken to a fault, politically incorrect in the extreme. His own political inexperience and tendency to be thin-skinned and shoot from the hip have tripped him up many times. Yet, whatever his defects, some of them glaring, Trump is authentic, intuitive, and is resonating spectacularly with the vast American middle class, especially men. Indeed, he has energetically and wholeheartedly aligned himself with the American people and their best interests.

Trump has two big issues. One is fixing the disastrous Obama economy by

replacing the disintegrating Obamacare, reducing burdensome taxes and business regulations, and bringing jobs back to America by renegotiating multinational trade deals now widely recognized to have decimated America's manufacturing base. Trump's other issue is safeguarding America's security in the face of increasing terror attacks, both by destroying ISIS and by halting America's suicidal immigration policies that currently give highest priority to Muslim immigrants from Middle East terror hotbeds.

Thumbing his nose at the establishment elite's globalist plans and sensibilities, Trump has unapologetically pledged that “America First” will be his compass for every economic, domestic and foreign policy decision he would make as president.

Hillary Clinton: Poster girl for post-Christian America

As Christian morality gives way to post-Christian liberalism, Marxism and secularism, we – to quote the man who could have saved America, Robert Bork – continue to slouch toward Gomorrah at an alarming rate. Paganism seems to infect every aspect of America from harsh, violent and pornographic television programming and movies to cheating and outright brutality in sports and insensitivity and crassness in our social relations. Truly, a society with no guilt or shame is retrogressive and bound for moral stupidity of the worse sort.

During my working years as a professor, psychotherapist and teacher of therapists, David Kupelian of *World Net Daily* declared, I occasionally saw a depressed client who felt guilt and shame over real or imagined misdeeds. But no more. People surely *regret* misdeeds that cost them money or prestige; they *apologize* profusely to evade responsibility; they suffer *heartbreak* after a loss; and they may exhibit the appearance of *shame* and *guilt* to suit some social end. But the real thing is not there – that is, great feelings of guilt and remorse privately felt after serious wrongdoing. Such is the social glue that holds modern societies together as increasing numbers of differing peoples rub against each other on the street, at work, on the Internet and social media.

What do the powers who have pushed 2,000 years of Christianity aside offer in its place? Basically, a vapid, philosophically superficial “moral agenda” called political correctness. PC is difficult to define since there is nothing of scientific or philosophical substance to it. Silly and superficial ideas like “diversity,” “multiculturalism,” “speech codes and safe zones,” “we are a nation of immigrants” and the like float about in the air unmoored by fact or intellectual substance.

Basically, the *New York Republic* and its minions in the media, the Ivy League, most colleges and universities, and the judiciary and Supreme Court first decide who the “good and bad guys” are in American society and then promote the former and punish the latter. Minorities, immigrants, liberal women, and socialists and Marxists of all stripes are to be favored, and anyone Christian, Caucasian and conservative is to be marginalized and punished as severely as possible. And don't forget – it is politically correct to vote for Democrats and the vilest form of incorrectness to vote Republican.

“Lying Hillary Clinton” is the poster girl for the politically correct, post-Christian age in America. She is a perfect illustration of how morally empty and philosophically barren the PC landscape and the world of secular law have become. Joseph Farah sees her “as an existential threat to life and liberty” and “perhaps the most corrupt major American political figure in the last 50 years,” and Dr. Herbert London says she is “the embodiment of evil.” Dr. Ben Carson even links her with Lucifer himself by virtue of her connection with Saul Alinsky!

The crazy, conspiratorial, paranoid world of Hillary Clinton

Hillary Clinton says, “Everywhere I go, people tell me how concerned they are by the divisive rhetoric coming from my opponent in this election,” she began, just minutes into what would be a memorable diatribe. “It’s like nothing we’ve heard before from a nominee for president of the United States. From the start, Donald Trump has built his campaign on prejudice and paranoia. He’s taking hate groups mainstream and helping a radical fringe take over one of America’s two major political parties. His disregard for the values that make our country great is profoundly dangerous.”

This was what her friends in the media had been preparing America for, even while new shocking details of her pattern of enriching herself through graft as secretary of state was finally being revealed, resulting in some of her closest allies and supporters demanding she shut down her \$2 billion family foundation, which was being exposed as a criminal enterprise.

Divisive rhetoric? Paranoia? Taking hate groups mainstream? Helping a radical fringe take over one of America’s two major political parties? Disregard for the values that made America great?

Who is guilty of all of those things? She might as well have been describing herself and her own party. No?

She went on to attack Trump for courting the black vote – which suggests it really threatens her and her party’s monopoly of a constituency they have exploited for political power for the last 52 years. Not long before that, the Democratic Party was the Ku Klux Klan and the Ku Klux Klan was the Democratic Party. It blocked civil rights legislation. It promoted segregation. It oversaw Jim Crow laws. That’s a history you may not know, but is finally getting more visibility thanks to Dinesh D’Souza’s new book and movie, “Hillary’s America,” and an earlier book by African-American author and TV personality Ben Kinchlow, “Black Yellowdogs.”

Here's how she distorted Trump's effective outreach to black voters: "Trump has stood up in front of largely white audiences and described black communities in insulting and ignorant terms: Poverty. Rejection. Horrible education. No housing. No homes. No ownership. Crime at levels nobody has seen ... Right now, you walk down the street, you get shot. Those are his words."

Those are his words, all right. But he wasn't blaming those communities for their plight. He was blaming the Democratic Party for fostering these conditions and, despite their campaign promises of the last 52 years, sustaining that misery and exploitation.

"Trump's lack of knowledge or experience or solutions would be bad enough," she claimed. "But what he's doing here is more sinister. Trump is reinforcing harmful stereotypes and offering a dog whistle to his most hateful supporters."

That's just ridiculous. Trump knew what he needed to do to win his campaign for the presidency. He needed to expand his base of support. And what offended Hillary the most is that he came after the very people she and her party count on with their empty promises that are never kept. All they get are patronizing words every election cycle while Hillary lives in the exclusive, lily-white environs of Chappaqua, New York.

"A man with a long history of racial discrimination, who traffics in dark conspiracy theories drawn from the pages of supermarket tabloids and the far reaches of the Internet, should never run our government or command our military," she said. "If he doesn't respect all Americans, how can he serve all Americans?"

This is the same Donald Trump whom she courted for campaign donations, the same Donald Trump she sought out for contributions to the Clinton Family Foundation, the same Donald Trump she invited to the wedding of her daughter. If that's what she believed about Trump, why would she do those things? Simple. She never believed them.

Once again, Hillary played the Alinsky card – accusing her opponent of what she does: It's Hillary and the Democratic Party that has the long history of racial discrimination, not Donald Trump and the Republicans. It's Hillary who has spent her entire public life trafficking in dark conspiracy theories. It is Hillary who should never run our government or command our military. It's Hillary who doesn't respect all Americans.

Said Joseph Farrar, "This is a sick, sick woman, full of hate herself, someone who is ethically challenged more than anyone who has ever run for the presidency, a woman who was 'co-president' in the 1990s when her husband used the Internal Revenue Service to target his and her political enemies – myself prominently among them.

He declared, “She does not deserve another chance. She is unfit. She is disqualified. Many who breached national security as she did as secretary of state are serving prison time. She and her husband have never been held accountable for their crimes – many of which were committed when they served in the highest offices in the land.” (wnd.com/2016/08/the-crazy-conspiratorial-paranoid-world-of-hillary-clinton).

Is Hillary Clinton a compulsive liar?

Compulsive liars lie with ease and without guilt. Often they are so caught up in their lies that they don't realize the distinction between fact and fiction. Their lies may be plausible on the surface, requiring some effort to disprove. Often the lies present the liar in a favorable or flattering light or else seek to hide failure.

Does Hillary Clinton fit this picture?

Hillary Clinton has a long history of tall tales. Some designed to make her appear brave, such as her lie about coming under sniper fire during a trip to Bosnia in 1996. Others connected her to someone famous, such as her claim to be named after Sir Edmund Hillary. Except that Sir Edmund, at the time of Hillary Clinton's birth, was simply Ed, an obscure New Zealand beekeeper.

Big deal – just embellished stories, like "the fish that got away." But what about when the lies are profound, involving national security or American lives?

Mrs. Clinton lied about a video causing the Benghazi terror attack and is now doubling down, denying she lied to the victims' families about the video, blaming her fabrication on the "fog of war." There's also her emails, which she lied about to Congress and the American people. These aren't the inconsequential fabrications about whom she was named after, but serious false statements involving loss of American life and compromised U.S. foreign policy and national security.

Perhaps Hillary's lies are a recent phenomenon, related to some illness or injury. Hillary suffered a concussion, or traumatic brain injury, in 2012. One of the side effects of such injury is confabulation, a type of unintentional lying that portrays the liar in a favorable light and that the liar is totally unaware of. This might explain some of Hillary's more recent fibs.

But lying is not a recent phenomenon for Mrs. Clinton. William Safire, of the NY Times, wrote in 1996 that Hillary "is a congenital liar." He noted a string of deception beginning in Arkansas and following her to the White House – cattle futures, Travelgate, Whitewater, lost billing records, and missing FBI files, to name some of her most prominent deceptions and cover-ups.

Going even farther back in history to the 1970s, Hillary Clinton was fired from her staff position on the Watergate House Judiciary Committee over "lies and unethical behavior."

Is a pattern of compulsive lying by a presidential candidate a legitimate concern? Are Mrs. Clinton's lies about Benghazi and emails part of a longstanding pattern? Are they consequences of her traumatic brain injury, described by her husband as "a terrible concussion that required six months of very serious work to get over"? Or worse, are her lies part of a more significant personality disorder?

What can't be ignored is a pattern of deceit, raising red flags as to the suitability of Mrs. Clinton for commander-in-chief. Simply looking the other way under the guise of a Hillary-ism – "What difference does it make?" – is not enough. (Brian C. Joondeph, *American Thinker*, January 26, 2016).

William Safire on Clinton's Lies

Noted columnist William Safire, one-time speech writer for Ronald Reagan, exposed Hillary Clinton's penchant for obfuscation and lying. He wrote in 1996, "Americans of all political persuasions are coming to the sad realization that our First Lady -- a woman of undoubted talents who was a role model for many in her generation -- is a congenital liar.

"Drip by drip, like Whitewater torture, the case is being made that she is compelled to mislead, and to ensnare her subordinates and friends in a web of deceit.

"1. Remember the story she told about studying *The Wall Street Journal* to explain her 10,000 percent profit in 1979 commodity trading? We now know that was a lie told to turn aside accusations that as the Governor's wife she profited corruptly, her account being run by a lawyer for state poultry interests through a disreputable broker.

"She lied for good reason: To admit otherwise would be to confess taking, and paying taxes on, what some think amounted to a \$100,000 bribe.

"2. The abuse of Presidential power known as Travelgate elicited another series of lies. She induced a White House lawyer to assert flatly to investigators that Mrs. Clinton did not order the firing of White House travel aides, who were then harassed by the F.B.I. and Justice Department to justify patronage replacement by Mrs. Clinton's cronies.

"Now we know, from a memo long concealed from investigators, that there would be "hell to pay" if the furious First Lady's desires were scorned. The career of the lawyer who transmitted Hillary's lie to authorities is now in jeopardy. Again, she lied with good reason: to avoid being identified as a vindictive political power player who used the F.B.I. to ruin the lives of people standing in the way of juicy patronage.

"3. In the aftermath of the apparent suicide of her former partner and closest confidant, White House Deputy Counsel Vincent Foster, she ordered the overturn of an agreement to allow the Justice Department to examine the files in the dead man's office. Her closest friends and aides, under oath, have been blatantly disremembering this likely obstruction of justice, and may have to pay for supporting Hillary's lie with jail terms.

"Again, the lying was not irrational. Investigators believe that damning records from the Rose Law Firm, wrongfully kept in Vincent Foster's White House office, were spirited out in the dead of night and hidden from the law for two years -- in Hillary's closet, in Web Hubbell's basement before his felony conviction, in the President's secretary's personal files -- before some were forced out last week.

"Why the White House concealment? For good reason: The records show Hillary Clinton was lying when she denied actively representing a criminal enterprise known as the Madison S.& L., and indicate she may have conspired with Web Hubbell's father-in-law to make a sham land deal that cost taxpayers \$3 million.

“Why the belated release of some of the incriminating evidence? Not because it mysteriously turned up in offices previously searched. Certainly not because Hillary Clinton and her new hang-tough White House counsel want to respond fully to lawful subpoenas. . . . Therefore, ask not "Why didn't she just come clean at the beginning?" She had good reasons to lie; she is in the longtime habit of lying; and she has never been called to account for lying herself or in suborning lying in her aides and friends.”

Clinton Criminal Conspiracy

Of all the astonishing, historic aspects of the 2016 presidential election, perhaps the most vexing is that something like half of America's voters seemed content to elect a pathologically lying career criminal as president.

How can this be?

Many people are just abysmally ignorant, as revealed by an Annenberg Public Policy Center poll showing almost two-thirds of Americans cannot even name the three branches of the federal government. Tens of millions are just not paying attention.

The establishment news media, so totally biased toward Hillary Clinton they abandoned their former pretense of objectivity, diligently labor to keep the electorate uninformed. They have been successful in protecting their favored candidate from public exposure of her three-decades-long record of crime, corruption and sleaze.

Even more inexplicable than the millions of low-information, left-of-center voters supporting Clinton despite her lifetime of corruption are the “NeverTrump” Republicans, some of whom actually claimed America would be better off under a Hillary Clinton presidency than under Donald Trump!

This despite the fact that repeated polls show fully two out of three voters, including many Democrats, believe Hillary Clinton to be utterly dishonest and untrustworthy and a majority want her indicted for crimes related to her private email server while secretary of state. It is likewise undisputed that her husband, former President Bill Clinton, is a serial sexual abuser. Yet these appalling aspects of the Clintons' record seem to be, as Democrat pundits say, “old news” – and already “baked in” to the way many people regard the Clintons.

Why does the American public continue to give the Clintons a pass on their lifelong, ever-cascading criminality and wickedness?

“Dishonesty, deceitfulness, demagoguery – traits typical of so many politicians – are things the public understands,” said Whistleblower Editor David Kupelian. “Lying they understand; politicians lie. Liberal versus conservative they understand, also pro-abortion versus anti-abortion, socialism versus capitalism, amnesty versus deportation, sexual anarchy versus biblical values. They understand that candidates hold very different views on these issues and support or oppose them on that basis.”

However, said Kupelian, “actual *criminality* – the kind that lands people behind bars – is something else, and the reality of Hillary and Bill as career criminals hasn't yet truly penetrated the public mind.”

Jerome R. Corsi in his powerful new book, *Partners in Crime*, presents detailed research and expert testimony proving beyond a shadow of a doubt that the Clinton Foundation is “a vast, criminal conspiracy” and “a slush fund for grifters.”

Corsi exposes how the Clintons amassed hundreds of millions of dollars in personal net worth, while building a \$2 billion empire in the Clinton Foundation. The victims are countless thousands of honest people who contributed their hard-earned money to what they thought were philanthropic causes. A national campaign to “Shut Down the Clinton Foundation” must be launched, Corsi insists, to prevent Barack Obama and other heads of state worldwide from following the Clinton Family crime formula to create their own “charitable foundations” to enrich themselves upon leaving office.

But Hillary’s attempt to take over the United States crumbled to dust when Donald J. Trump won the presidential election on November 8, 2016. Was this outcome predicted in the Bible?

Clinton and Trump in Bible Gematria

Gematria, or Hebrew numerology, is an esoteric device used by rabbis for revealing hidden meaning in the Bible. When applied to the US presidential candidates, the results are absolutely shocking and carry serious implications about the role of the upcoming election in the imminent Messianic era.

Joe Gallis and Dr. Robert Wolf lectured and wrote for almost two decades on Torah-related topics. One of their specialties was using Gematria to understand current events. In 2009, after Hillary Clinton lost the Democratic primaries to Barack Obama, they predicted on their blog, *Redemption 5768*, that her influence on Israel and the Messianic process was far from over. They used the numerology of her name to come to this remarkable conclusion.

Gallis and Wolf calculated that Hillary (הירליה), Rodham (מהדור), and Clinton (זוטנילק) each equal 255. The word for a female from the nation of Amalek (היקלמע) is also 255. Amalek is the archetypical evil that Israel is commanded to oppose anywhere and at any time.

The total of all three of her names is 765 (255 x 3), which is the same value as תע הרצ (“time of terrible distress”). The term תע הרצ comes from the Book of Daniel, which describes the time when Michael, the guardian angel of Israel, will stand in defense of his people at a time of catastrophe.

“And at that time shall Michael stand up, the great prince who standeth for the children of thy people; and there shall be a time of trouble, such as never was since the beginning of the world” (Daniel 12:1).

Hillary Rodham Clinton is also the Gematria of פְּלֵה בְּחַמֵּי תָהּ (daughter-in-law against her mother-in-law), which is seen in a verse in Micah.

“For the son dishonoureth the father the daughter riseth up against her mother the daughter-in-law against her mother-in-law; a man’s enemies are the men of his own house” (Micah 7:6).

Hillary Clinton has frequently been quoted in the media saying harsh and demeaning things about her deceased mother-in-law, even blaming her abuse for Bill Clinton’s infidelity. Her connection with the verse hints at negative family values in general.

The Torah website *Yeranen Yaakov* points out that the gematria of Donald Trump (פמארט דלנוד) is 424, or 212 x 2. The gematria of Bernie Sanders (סרדנס ינרב) is 636, or 212 x 3. *Yeranen Yaakov* quotes the Ben Ish Chai, an authority on Jewish law and master Kabbalist who lived in Baghdad 150 years ago. The Ben Ish Chai interpreted the number 212 as a difficult time for Israel before the Final Redemption.

“There are 212 hours in the first 9 days of Av (the eleventh month in the Jewish calendar) that are meant to be bad for the Jewish people,” *Yeranen Yaakov* wrote. “Although the 9 days contain 216 hours, the final 4 hours of *Tisha B’Av* (the ninth of Av) are sweetened since that is when Messiah is to be born.”

Yeranen Yaakov interprets this to mean that a Donald Trump (424) presidency will be doubly bad for the Jewish people, while a Bernie Sanders (636) presidency will be

triply bad for the Jewish people. But in either case, the dark period is the anticipated necessary step immediately preceding the Messiah.

It is also remarkable to note that Donald Trump (424) is the Gematria of “Messiah for the House of David” (דוד בן דָּוִד). That is not to say that Donald Trump is the Messiah, but that his presidency will usher in the Messianic era.

Gematria is not an exact science; it is famously open to interpretation. However, it is a widely used and generally accepted system of understanding the hidden meaning and layers of the word of God as written in the Hebrew Bible. It is studied and taught by a multitude of major rabbis and Jewish thinkers. It has been a part of Biblical interpretation, with examples in the Mishna (the oral law) dating from the first century, and in later times became the realm of Kabbalists. While Gematria cannot predict the outcome of the upcoming elections, there is no question that the Bible has something to say about our modern world. Is Donald Trump a Messiah-Like Figure?

Donald Trump has been called a lot of things. “Messiah” probably isn’t one of them. However, a Jewish rabbi from New Jersey, however, is making that claim, making clear in the process that he doesn’t see the GOP presidential nominee as *the* Messiah but rather *a* messiah.

Rabbi Mendel Kessin, during a lecture shared in late August, said Trump will play the role of a “messiah-like figure” leading America, which he sees as leader of Western Christianity, into its role as the rehabilitated biblical Esau – a righteous nation that repents of its past sins and becomes a helper of Israel.

Trump, the GOP nominee for president, will be a factor in the end of days in America by reflecting the “rehabilitation of biblical Esau,” said Kessin.

The rabbi’s lecture, which took place in Lakewood, New Jersey, begins with Esav, also called Esau, the twin brother of Jacob, who is portrayed in the Old Testament as a persecutor of the Jews.

Yet Kessin, speaking about the spiritual underpinnings of the 21st century, suggests that, at the last days, the biblical Esav [Western Christianity] will be rehabilitated with the United States leading the way.

Kessin connects Esav throughout history to Edom, Rome, Christianity, Western civilization and, ultimately, to the United States.

“At the end of days, the rabbi contends that the sins of Esav will be removed and Esav will become God-fearing,” writes Rivkah Lambert Adler for *Breaking Israel News*.

“Esav has in Jewish tradition been associated with oppressing, persecuting and afflicting the Jews, but at the end of days he will undergo a fundamental change in his character.”

Rather than harming Jews, Esav will turn toward serving the Jews, assisting them in doing God’s will in the form of mitzvot (biblical commandments), Adler reports. “As a result, Esav will be rehabilitated and earn a place in the world to come.”

Kessin believes Trump has a critical role to play in purifying the U.S. “What I believe is that the one who is going to switch from [Esav persecuting the Jews] to [Esav serving the Jews] is Donald Trump,” he says. “He’s going to purify Edom.”

At the 43-minute mark of the lecture, Kessin says the Hebrew numerical value of Donald Trump is the same as that of Moshiach ben David (Messiah son of David). He quickly assures his listeners that Trump is not the long-awaited Messiah of the Jewish people. At the same time, Kessin plainly asserts that Trump has the qualities of a messiah-like figure.

“Someone who will turn a nation completely, diametrically opposite is a messiah,” Kessin says. “He further contends that good times will return to the U.S. under the leadership of Trump because “Peace and prosperity must happen in order to rehabilitate the Jews in America, to prepare them for Moshiach (Messiah).”

‘Coming out of nowhere’

Using three biblical examples, Kessin builds his case that Trump is a messiah-like figure. First off, “A messianic figure is always despised,” he argues. He cites Joseph, who was imprisoned; Moses, who had to run away from Pharaoh to escape being killed; and King David, who was rejected many times in his lifetime.

“Many messianic figures, they come out of nowhere . . . Everybody is expecting the Moshiach to be this incredible (righteous individual), incredible gadol (great person), unbelievable talmid chacham (Torah scholar),” he said. “Yeah, eventually he will be. But he’s the guy that you don’t even look at twice. That’s who a Moshiach is. And you find all the (messianic figures) were always despised...”

“That’s why there’s so much opposition to Trump. Because he’s about to start something which is a major reversal of the job of Esav from [oppression of the Jews] to [serving the Jews].”

Trump as a great reformer

Carl Gallups, a Baptist pastor in Florida, radio talk-show host and author of several Christian books including “*Be Thou Prepared*,” comments on Rabbi Kessin’s observations. He says, “I think the main thrust of Rabbi Kessin’s message is that, somehow, Yahweh [Yehovah] might be in the process of using Donald Trump to bring about some much-needed biblical reformation to the United States and, thus, the world.”

“I think he is also hoping and praying, along with much of the Jewish and Christian world, that Trump might be used of God to restore the United States to being a great friend and protector of Israel. This is especially true as we see the miraculously returned Israel now surrounded with nations on every side that are plotting its ultimate demise.”

“People all over the globe have a sense of urgency, expectancy, and trepidation about the future,” he said. “Even people who don’t claim to be ‘believers’ or Christians, even those who never go to church or read the Bible are asking, ‘What’s wrong with the world? Why is the Middle East the center of such huge international turmoil? Are we on the verge of World War III?’”

Gallups said he understands what Kessin is trying to say, viewing Trump in many ways as the antithesis of President Obama.

“He’s looking at it in the same way that a number of Christians and even biblical scholars have examined Obama’s journey, candidacy, and eight-year presidential legacy and point out his clearly ‘antichrist’ characteristics without ever believing him to be, or declaring him to be, the actual antichrist,” Gallups said. “I don’t think there is anything unbiblical about examining the times in which we live, and the world-impacting leaders of our times, and noting the biblical characteristics of those that Yahweh [Yehovah] may be using for His ultimate purposes in our highly prophetic era.”

“I also find it remarkable,” Gallups added, “that Rabbi Kessin outlined the qualities of a messianic figure as being that of a powerful person, a great person, a biblical scholar, a righteous individual, and one who is at the same time also ubiquitously despised, while seemingly coming ‘out of nowhere.’ These very same things can be said of the real and ultimate Messiah, Yeshua/Jesus.”

“I feel for Rabbi Kessin. I know he understands that we are now living in profoundly prophetic times. I get that. I am continually writing about and speaking to this issue as well – all over the world. There certainly seems to be something very numinous about this year’s presidential election. It may be the most important one in the history of the United States and, thus, the world. And with that feeling – he is looking for answers, and possible biblical connections.” (see www.wnd.com/2016/09/trump-as-american-messiah-rabbi-says-yes).

The Bible Codes

Rabbi Matityahu Glazerson, an international Bible codes expert who has written 30 books, says it’s a fait accompli for Donald Trump. He will beat Hillary Clinton on Nov. 8 and go on to become the next president of the United States.

Glazerson sees Trump as a leader in the mold of Cyrus the Great of Persia, who helped free the Jewish people from Babylonian captivity in Old Testament times. They were then able to rebuild the Temple in Jerusalem.

Any international leader who helps the Jewish people is a type of “moshioch” or a messiah figure, he says in a three-minute video posted in late October to YouTube. Not *the* Messiah but a messiah.

Glazerson says “anybody who helps Israel, to build themselves, to settle properly in their land,” is referred to as a kind of moshiach.

This is the second video the rabbi has made about Trump’s appearance in the Bible code.

Judaism’s greatest mystical text ‘predicts Trump victory’

Times of Israel, Nov.2, 2016, reports that an unnamed ultra-Orthodox expert on the seminal ‘Zohar’ work, Marc Zell, says Trump campaign staffers in US were ‘amazed’ at the news that Judaism’s ancient text, the Zohar, appears to have predicted a Trump victory in the presidential race in the United States.

The head of the Republican Party’s branch in Israel told an ultra-Orthodox website that an unnamed but “great” Jewish mystic told him Judaism’s major mystical work predicts an election victory for Donald Trump.

Attorney Marc Zell, head of Republicans Abroad Israel, told Yanky Farber, a columnist for *Behadrei Haredim*, “But in the last two weeks, a decision has been made among the rabbis of all sorts of streams in the Haredi public in Israel that Trump is the one who will defend Jerusalem, the Land of Israel and the Jewish people.”

He then told Farber that a *mekubal*, or sage steeped in the Jewish mystical tradition of Kabbalah, had informed him that according to the tradition’s seminal text, the Zohar, Trump will be the next president of the United States.

“Two days ago, a great *mekubal* came to me — I don’t want to say his name — with all his entourage from Bnei Brak, just to give me this message for Donald Trump,” Zell reportedly said. “According to the rabbi, the Zohar says Donald Trump will win next week. The rabbi didn’t ask for anything, but just wanted to send this message.”

Zell said he “passed this on to the Trump campaign in the US and the Jewish advisers were amazed, in a good way, about this news.”

He recalled comments made last month by Trump’s Israel adviser, David Friedman, according to which Trump, if elected, would fire any American official who opposed an order to move the US embassy from Tel Aviv to Jerusalem.

Everyone says they’ll move the embassy to Jerusalem. American law requires moving the embassy, but all the presidents vetoed it, arguing it would hurt American security.”

Trump is different, Zell insisted. “That’s Donald Trump. He comes from outside the establishment and doesn’t think like a run-of-the-mill politician. He says what he thinks.”

The mysterious mystic was not the only Haredi leader cited by Zell as supporting Trump. The head of a major Jerusalem *cheder*, or religious elementary school, “came to vote today,” Zell said. “He told me he had decided to vote, and explained to his students why he did so — because of the values of the Republican Party, belief in the Creator of the world and family values. I feel we have something in common.”

The Behadrei Haredim report concluded by quoting a Haredi halachic authority, Rabbi Sraya Deblitzky, who told his followers to “vote for the man. If a woman rules, it brings judgment, death and poverty.”

The Miracle Election

The years ahead promise to be years of tumult, confusion, violence and unparalleled strife and suffering. America stands at a crossroads. The fate of the country lies in the balance. Clinton's Body Count: 5 Found Dead, All Linked To DNC

Burning Man: America's Largest Occult Festival Is A Celebration Of Weirdness And Hedonism

70,000 people have descended upon a very bleak stretch of Nevada's Black Rock Desert for what is perhaps the largest celebration of hedonism on the entire planet. Burning Man has been described as a "dystopian hellscape", and that description is not too far from the truth. From August 25th to September 5th (Labor Day Monday), revelers from all over the world will dance, carouse and "express themselves" in a temporary city that has been created entirely by its citizens. This festival is part Mad Max, part Woodstock and part Eyes Wide Shut, and many "Burners" look forward all year long to these eight days of completely unrestrained hedonism.

30 years ago, Burning Man began as a small beach gathering in San Francisco. Initially held during the Summer Solstice, it quickly took on a life of its own and was moved to Nevada in 1990. Ever since then, this eight day party has not stopped growing, and people literally fly in from all over the world to witness one of the most bizarre spectacles in America.

To say that Burning Man is "weird" would not be doing it justice. In this very isolated corner of the Black Rock Desert, you will find nudists

(lots of them), palm readers, neopagans, “ecosexuals”, witches, sorcerers, shamans, New Age gurus, “goddesses”, Satanists, “polyamorists” and just about every type of fetishist that you can possibly imagine.

The reason why the festival is called “Burning Man” is because of the gigantic effigy that is burned toward the end of the eight day celebration. Nobody is physically harmed during the burning of this enormous “wicker man”, but it does seem to parallel the human sacrifices that the Druids would do in ancient times. The following comes from Wikipedia...

While other Roman writers of the time, such as Cicero, Suetonius, Lucan, Tacitus and Pliny the Elder, described human sacrifice among the Celts, only Caesar and the geographer Strabo mention the wicker man as one of many ways the Druids of Gaul performed sacrifices.^[6] Caesar reports that some of the Gauls **built the effigies out of sticks and placed living men inside, then set them on fire to pay tribute to the gods.** Caesar writes that though the Druids generally used those found guilty of crimes deserving death, as they pleased the gods more, they sometimes used slaves and innocent men when no delinquents could be found.^[7]

And even today, the burning of “wicker men” is very much associated with neopaganism. Here is more from that same Wikipedia article...

Wicker men are set ablaze during some neopagan festivities. A female effigy of wicker or other materials is burnt at the stake for the annual Danish celebration of Sankt Hans aften (Saint John’s Eve). Typically, Celtic neopagans, Neo-druids, are those who use such a motif in their festivities because they, unlike other neopagan groups, are either inspired by, or follow a reconstructed form of, Celtic paganism^[citation needed]. At other times, neopagans do not burn wicker men, but keep them as idols for protection, often merging them with the Green Man. **Neopagan wicker men range from life sized to huge, humanoid, temporary sculptures that are set ablaze during a celebration, usually toward the end of the event.** They are constructed with a wooden frame that is woven with flexible sticks such as willow often used in wicker furniture and fencing. Some wicker men are extremely complex and require days of construction.^[9]

Of course the organizers of Burning Man strongly deny that it is an overtly occult festival, but it is undeniable that thousands upon thousands of occultists from all over the planet are drawn to this celebration each year.

However, there are many others that go to Burning Man just for the sex, drugs and techno music.

During these eight days people openly and freely use illegal drugs, and the authorities don’t seem to mind. Public nudity is also constantly on display, but once again law enforcement is nowhere to be found. Actually, if they are there it is usually to participate in the debauchery.

The biggest draw of all, however, is the casual sex that is absolutely rampant at Burning Man. And it isn’t just one on one sex that we are talking about. That would be way too boring. This is how the Daily Mail described what goes on during these eight days...

Sex between ‘Burners’, as festival-goers are known, is known variously as ‘**dust love**’ or ‘**tent trysts**’, and old hands suggest it is simply ‘selfish’ to stick to monogamy. **Public nudity**, especially by women, is actively encouraged, while **orgies — or at the very least partner swapping, if not threesomes** — have become just as much a feature of Burning Man as the ceremonial torching of a huge wooden effigy of a man to celebrate the summer solstice.

Group sex is actively encouraged at so-called ‘theme camps’ — giant tent complexes where free bars encourage visitors to loosen up and participate. A popular venue is the so-called ‘**Orgy Dome**’, run by a group calling itself And Then There’s Only Love, though conventional notions of love are hardly what’s fostered inside its giant dome tent.

If the “Orgy Dome” is not your style, there are definitely other kinky activities available...

The Orgy Dome is hardly alone. There is also a ‘**Group Sex Bus**’, the ‘**Sex Libido Lounge**’, and a Canadian-run club with an unprintable name where judges give points to amorous couples for ‘style’ and ‘inventive poses’.

To some of you reading this article, this may sound like paradise.

In fact, some of you might be thinking that you may want to attend Burning Man next year.

But the truth is that there is such an emptiness to this kind of reckless animal behavior. People “let loose” to try to give meaning to their otherwise meaningless lives, but any pleasures that are enjoyed are quite fleeting. In the end, many participants return to their “normal lives” feeling even emptier than before. This is how an editorial in the New York Post put it...

Sure, it looks fun to spend a few days enjoying a gift economy, listening to techno, cooling off in refrigeration trucks and gawking at surreal sculptures or taking in offbeat performance art. But, according to Daniel Yudkin, a social psychology Ph.D. candidate at New York University, as reported by Quartz, the eight days of decadent hedonism provide once-a-year opportunities for attendees to experience bona fide connections with others. All the other non-Burning days of their lives? Not so much.

Rather than reflecting how much fun Burning Man is, the reality of people spending thousands of dollars — on travel, accommodations, tickets and drugs — serves as proof that their non-Burner days are pathetically empty. “I think the fact that people invest so much of their own resources and time and energy to going to Burning Man suggests that there’s something missing, that there’s something Burning Man fulfills for them that they don’t get in day-to-day life,” Yudkin says.

Ultimately, the truth is that you are not going to find meaning in life through sex, drugs, public nudity, weird art and loud techno music.

You can try every pleasure under the sun, but it is still not going to fill that hole that you feel deep inside of you.

In America today, there is a greater spiritual void than ever before. People are searching for meaning and purpose in all sorts of places and not finding it.

Unfortunately, I think that this helps to explain the popularity of Burning Man. Multitudes of

Americans are deeply dissatisfied with their regular lives, and they are searching for something real.

Sadly, the revelers at Burning Man are not going to find anything real to soothe their aching hearts. Instead, they will only find more pain, more frustration and more emptiness. (By Michael Snyder, on August 31st, 2016).

The Truth about Huma Abedin

For nearly 20 years, Hillary Clinton has had an extremely close working relationship with a young beauty who was raised in Saudi Arabia.

Hillary’s ties to Huma Abedin go so deep, it’s been said that the vice chairwoman of Hillary’s campaign is one of few people who knows where the proverbial Clinton “bodies are buried.”

In fact, Abedin, whom Hillary once called her “second daughter,” had direct access to classified national security information stored on Hillary’s unsecured email server. Abedin had served as Hillary’s deputy chief of staff at the State Department. And it’s been widely predicted that Abedin would serve as chief of staff if Hillary wins her race for the White House.

But *who* is this woman, and *why* is she privy to some of America’s deepest national security secrets?

WND has long reported the hair-raising details of Abedin’s past. Abedin has known ties to the Muslim Brotherhood — a group bent on “destroying Western civilization from within” — and other Islamic supremacists. As WND has extensively reported, the Muslim Brotherhood and Islamic supremacist connections not only extend to Abedin’s mother and father, who are both deeply tied to al-Qaida fronts, but to Abedin herself.

As WND reported, a manifesto commissioned by the ruling Saudi Arabian monarchy places the work of an institute that employed Abedin at the forefront of a grand plan to mobilize U.S. Muslim minorities to transform America into a Saudi-style Islamic state, according to Arabic-language researcher Walid Shoebat.

Abedin was an assistant editor for a dozen years for the Journal of Muslim Minority Affairs for the Institute for Muslim Minority Affairs. The institute – founded by her late father and currently directed by her mother – is backed by the Muslim World League, an Islamic organization in the Saudi holy city of Mecca that was founded by Muslim Brotherhood leaders and helped fund the Sept. 11, 2001, terror attacks. The 2002 Saudi manifesto shows that “Muslim Minority Affairs” – the mobilizing of Muslim communities in the U.S. to spread Islam instead of assimilating into the population – is a key strategy in an ongoing effort to establish Islamic rule in America and a global Shariah, or Islamic law, “in our modern times.”

WND reported Abedin also was a member of the executive board of the Muslim Student Association, which was identified as a Muslim Brotherhood front group in a 1991 document introduced into evidence during the terror-financing trial of the Texas-based Holy Land Foundation.

At her father’s Saudi-financed Islamic think tank, WND reported, Abedin worked alongside Abdullah Omar Naseef, who is accused of financing al-Qaida fronts. Naseef is deeply connected to the Abedin family.

WND was first to report Huma’s mother, Saleha Abedin, was the official representative of Naseef’s terror-stained Muslim World League in the 1990s. Less than one month after the Sept. 11, 2001, terror attacks, Newsweek reported that the Muslim World League was used by terror mastermind Osama bin Laden to finance his operations:

“Two interrelated global charities directly financed by the Saudi government – the International Islamic Relief Organization and the Muslim World League – have been used by bin Laden to finance his operations. The organizations were left off the list of groups sanctioned by the United States last week, U.S. officials hinted to Newsweek, in order to avoid embarrassing the Saudi government.”

Harper’s magazine confirmed the relationship in 2004: “In other cases, the Bush Administration made a conscious decision not to pursue major Saudi conduits for terrorist funding. The clearest example involves two ostensible charities that

are long known to have funneled money to Al Qaeda – the International Islamic Relief Organization (IIRO) and the Muslim World League (MWL). Both are financed directly by the Saudi government. MWL is an evangelical organization that was created to help spread Wahhabism, the Saudi brand of Islamic fundamentalism; IIRO is a humanitarian relief organization that operates primarily in Muslim countries.”

Shoebat previously reported that as one of 63 leaders of the Muslim Sisterhood, the de facto female version of the Muslim Brotherhood, Saleha Abedin served alongside Nagla Ali Mahmoud, the wife of Muslim Brotherhood figure Mohammed Morsi, Egypt’s now ousted president.

Saleha Abedin and Morsi’s wife both were members of the Sisterhood’s Guidance Bureau, Shoebat found.

WND reported Abedin used emails hosted on Hillary’s private server while she was secretary of state. WND also reported in August that Abedin forwarded classified national security information to one of two personal, unsecured emails she regularly used to transact State Department business.

Corsi told Radio America he believes Hillary and Abedin offloaded emails onto Abedin’s Yahoo account in preparation for a pay-to-play scheme for access to her emails.

**'We're being invaded right now'
Michael Savage describes Obama's
'Scorched Earth' approach to
demographic warfare**

History isn't about tolerance or peace or understanding. History is about war. History is about conflict. History is about invasions – and the most consequential invasion in human history is well underway.

"We're being invaded right now," says talk-radio host and best-selling author Dr. Michael Savage.

"We're being invaded from the south. We're being invaded from the north, from the east and from the west. You might say, 'Well, that's the way of things,' and you might get used to it. They're here, they're near, they're everywhere. The question is, why are liberals so quick to embrace this invasion, and why are traditionalists and conservatives like myself so resistant to erasing the borders, language and culture of this great nation?"

More than 3 million foreigners came to the United States in 2014 and 2015 according to a new report from the Center for Immigration Studies. The foreign-born population in the United States, now standing at 43.3 million people, is at an all-time high. Immigrants now make up almost 14 percent of the population, the highest percentage in 105 years.

And the rate of immigration is increasing. If current demographic projects are left unchanged, immigrants will compose a record share of the population in seven years.

It's not just the number but the origin of these new residents which is causing concerns.

Border Patrol officials say an increasing number of would-be illegal immigrants are arriving from nations around the world, including from outside the Western Hemisphere. The number of "refugees" is also on the rise, especially from Muslim nations. Some 13,210 Syrian refugees have been welcomed into the United States by

the Obama administration so far in 2016. More than 99 percent are Muslims.

The increased demand upon the welfare and social services by immigrants is also putting financial pressure on many communities. And sometimes, even the Muslim immigrants on welfare still end up fighting for the Islamic State.

In his new book, "Scorched Earth," Savage unloads on Barack Obama, Angela Merkel and other Western leaders who are "invading their own countries" to deliberately deconstruct them.

Savage challenges the premise Obama is a weak leader who is being taken advantage of. The truth, he suggests, is that Obama and other pro-immigration leaders know exactly what they're doing.

"Barack Hussein Obama, a president who was never touched personally by oppression, has one of the strongest wills I've ever seen, similar to those of other very dangerous leaders," Savage claims. "Look at Germany, at Belgium, at America, at the guilt-edged humanitarian rush to bring in Syrian Muslims and Bosnian Muslims. No one knows who they are or where they're really coming from. Ninety percent of them are men without women and children. Of course, the news media are modifying that reality to suit their liberal agenda. They are showing us pictures of older men, frightened women, and hungry children. But we all know that the influx to Europe is 85 to 90 percent single men of military age.

"Obama is invading his own country. He's destroying it from within, like a worm in an apple –or the communist mayor in the Big Apple. He began with illegal aliens from Mexico, Honduras, El Salvador, Guatemala, and China. Using glib lies and illegal executive orders, and unchallenged by the complicit mainstream press, he is making his own people stand down. He's making the local police stand down. He's making the border patrol stand down. They were illegal Mexicans living in a refrigerator box on a hillside in Riverside County, California. The Immigration and Naturalization Service was summoned – and took no action."

Savage accused Obama of being a "psychopath" deliberately trying to destroy the United States

and the rule of law.

"He invades his own country with a de facto army from other nations, foreigners who are not even citizens, who have no visas or legal right to be here," he thundered. "He wipes away the laws of his own land. He permits illegal aliens to vote. If that's not psychopathic behavior, tell me what is."

Dr. Savage sees a primal hatred animating Obama, Merkel and other leaders seemingly possessed by a fanatical desire to replace the populations of their own countries.

"Two of the hallmarks of the psychotic are egotism and the need to destroy," he pronounces. Hillarygate

When it comes to the Clintons, it's been said there are two standards of justice: One for them and another for the rest of us.

Yes, it seems almost daily, Democratic Party nominee Hillary Clinton proves that America's laws are for little people. The Clintons have survived at least 25 explosive scandals – and the list grows by the day.

As WND has reported, the Clintons brought a load of baggage with them into the White House from their days in Arkansas.

After the Clintons moved into the presidential mansion, the political scandals multiplied – from use of the IRS and FBI to target political opponents to stalking and harassing subjects of Bill Clinton's sexual advances and even attempts to loot taxpayer-funded items from the White

House and State Department. Americans also witnessed capers such as Travelgate, Chinagate, Filegate and Pardongate.

Bill Clinton's sexual escapades and subsequent impeachment by the U.S. House of Representatives on charges of perjury and obstruction of justice consumed more than a year of American public life and bitterly divided the nation.

In the years since the memorable Clinton presidency, Hillary has brought America Emailgate, the Benghazi scandal, the "Clinton U" scam and scandals involving the Clinton Foundation, among others.

Now, it's Hillary's "turn" to be president, according to her Democrat supporters.

But in 2016, America is still apparently suffering from "Clinton fatigue."

Results from a new poll by the Washington Post revealed only 38 percent of Americans believe Hillary is more honest and trustworthy than her GOP rival.

In 2003, ABC News' Barbara Walters referenced numerous Clinton scandals from Whitewater to Travelgate and the death of Hillary law partner Vince Foster in an interview with then-Sen. Clinton.

Walters asked Hillary, "How did you get in this mess where your whole credibility is being questioned?"

Hillary's response: "Oh, I ask myself that every day, Barbara, because it's very surprising and confusing to me."

With the prospect of another Clinton presidency looming, is America ready for a repeat of the Bill and Hillary "drama" in the White House?

If, as psychologists say, "The best predictor of future behavior is past behavior," then a fresh look at the top 25 scandals involving Hillary is in order.

1) Clintons turn IRS into 'gestapo'

Few federal agencies are more feared and loathed by Americans than the Internal Revenue Service – especially when corrupt presidents abuse the power of the IRS to harass and exact revenge on political enemies. As WND has reported, during Bill Clinton's terms in office, IRS audits were conducted against individuals and groups who caused problems for the administration. Several prominent conservative groups found themselves facing IRS audits following their criticism of the president and his policies. Among the conservative groups targeted for audits were the Heritage Foundation, the National Rifle Association, Concerned Women of America, Citizens Against Government Waste, National Review, American Spectator (which was burglarized three times), the National Center for Public Policy Research, the American Policy Center, American Cause, Citizens for Honest Government, Progress and Freedom Foundation, David Horowitz's Center for the Study of Popular Culture and the Western Journalism Center.

Individuals singled out for audits during the administration included Clinton paramours Jennifer Flowers and Liz Ward Gracen, sexual assault accusers Paula Jones and Juanita Broaddrick, fired White House Travel Office Director Billy Dale and attorney Kent Masterson Brown. Fox News' Bill O'Reilly, an outspoken critic of both Bill and Hillary Clinton, said he was audited three times during the Clinton presidency.

A 1996 survey by the Washington Times could not identify a single liberal public policy organization that had been audited during the entire Clinton administration.

In her Oct. 18, 2016, Washington Times column, "Hillary's IRS – a sneak preview," Washington, D.C., political law attorney Cleta Mitchell warned of the dangers of a Hillary Clinton presidency with a maximum Clinton donor at the helm of the IRS.

Mitchell noted that IRS Commissioner John Koskinen has contributed at least \$51,550 to the DNC, Democratic Party candidates for Congress and the presidential campaigns of John Kerry, Barack Obama and Hillary Clinton since 1997.

Koskinen donated to Hillary's Senate campaign in 1999 and 2000. He also gave maximum

contributions to Hillary's 2008 campaign for the White House. Since 1999, Koskinen has contributed \$6,800 to Hillary's campaigns.

"A Hillary Clinton presidency, with a maximum Clinton donor running the IRS, would not bode well for conservative organizations, donors, activists and sympathizers," Mitchell warned.

She continued, "As long as the liberal media and congressional Democrats collude with Democratic administrations in their targeting and attacking of conservatives, the Democrats in the White House will feel free to use the agencies of the federal government – including the IRS – as political weapons against those who criticize and disagree with them.

"A Hillary Clinton presidency, with an IRS commissioner who has long been an ardent political supporter and donor, does not present a very encouraging picture of a non-political IRS that will resist being used as an arm of the Democratic White House."

2) Covering Bill's dirty deeds

The Clintons have been accused of hiring private investigators to not only dig up dirt on perceived adversaries – such as Juanita Broaddrick, the woman allegedly raped by Bill, and other abused women such as Gennifer Flowers, Kathleen Willey and Paula Jones – but to stalk, scare and threaten them. Willey asserts Hillary was behind a campaign of intimidation and harassment against her that fit a pattern employed against numerous other women whose claims of sexual impropriety or assault by Bill Clinton threatened the couple's political fortunes.

As WND reported, Willey and her husband, Ed, were Democratic activists who founded Virginians for Clinton and helped send Bill and Hillary to the White House in 1992. While serving as a volunteer in the White House and facing financial hard times, Willey says she met with Bill Clinton in the Oval Office to request a paying position. But instead of getting help, she says, she was subjected to "nothing short of serious sexual harassment." Distraught, Willey fled Clinton's presence, only to discover that her husband Ed had committed suicide that same tragic afternoon. Later, she was drawn "unwillingly" into the Paula Jones lawsuit, the

Ken Starr investigation and impeachment proceedings.

Willey, author of the 2007 book, "Target: Caught in the Crosshairs of Bill and Hillary Clinton," has claimed the Clinton tag team used mob-style intimidation campaign to keep her silent, even purportedly breaking into her home to steal her memoirs of the events.

Despite Bill's 20 years of alleged and admitted extra-marital relationships, Hillary famously came to his defense shortly after the Monica Lewinsky affair broke in 1998. Asked about the accusations, the then-first lady said, "Certainly, I believe they're false. Absolutely."

Then, in a memorable interview with the "Today" show's Matt Lauer, she explained years of accusations by women such as Willey, Gennifer Flowers and Dolly Kyle: "Bill and I have been accused of everything, including murder, by some of the very same people who are behind these allegations," she said, pointing to a "vast right-wing conspiracy. ... So from my perspective this is part of a continuing political campaign against my husband."

Later, however, when placed under oath, Bill Clinton admitted to an affair with Flowers, as he did with Lewinsky. But Hillary's actions, Willey contends, indicated by word and deed that her main concern was to ensure her husband's proclivities didn't ruin their political careers.

In her book, Willey cites sources who contend Hillary began engaging private investigators during their time in Arkansas so she could head off any repercussions from her husband's behavior. The first to be dispatched were her own father and brother when she committed to marry Bill, according to author Jerome Levin in "The Clinton Syndrome." Bill had left Yale University for Arkansas to teach law, and she went to work in Washington, D.C.

When Bill was governor, Hillary sent out a group of investigators known at the "Truth Squad" to discourage many of her husband's lovers from going public.

As WND reported in October, novelist Jeff Rovin, who has claimed to be a Clinton "fixer" hired to clean up their "dirtiest schemes,"

revealed the Clintons have an open marriage, buy off news reporters and coordinated a scheme to destroy Lewinsky after her affair with the president. Rovin said the process would go like this: he would get money from an unidentified person. Then he would pay off “reporters,” who would pay off sources, wait staff, limo drivers and others.

In one case, he said he was tasked with participating in a “team effort” to damage Lewinsky. He said destroy “was the original concept.”

3) Looting the White House & State Department

When the Clintons left 1600 Pennsylvania Avenue in 2001, they reportedly vandalized and looted the White House. Hillary tried to ship furniture to the Clintons’ personal home in Chappaqua, New York. The Clintons came under fire when they reportedly tried to take \$190,000 in gifts and furnishings from the presidential mansion. Additionally, the General Accounting Office, an investigative arm of Congress, reported that “damage, theft, vandalism and pranks did occur in the White House complex” during the presidential transition from Bill Clinton to George W. Bush – including the theft of a presidential seal. According to the General Accounting Office, the cost of the White House vandalism reached about \$14,000 and included \$4,850 to replace computer keyboards with damaged or missing “W” keys. The agency said some of the destruction was intentional, including glue smeared on desks, broken furniture, offices full of trash and graffiti in a men’s restroom stall that disparaged Bush. There were also missing doorknobs, medallions and office signs.

During their time in the White House, the Clintons also reportedly auctioned off and sold taxpayer-financed government goods and services in exchange for political campaign contributions and personal profit. Among the items sold by the Clintons, which Judicial Watch uncovered in various lawsuits, and the media and Congress in their investigations, were: 1) seats on overseas trade missions; 2) export licenses for high technology sales to communist China and elsewhere; 3) commissionerships and judgeships; 4) rides on Air Force One; 5) overnight stays in the White House’s Lincoln Bedroom; 6) graves

at Arlington Cemetery; 7) meetings with key Clinton-Gore administration leaders; and other favors.

Hillary also reportedly looted the State Department when she served as secretary of state. A State Department staffer told the FBI, “[E]arly in Clinton’s tenure as secretary of state, she and her staff were observed removing lamps and furniture from the State Department, which were transported to her residence in Washington, D.C.” The staffer didn’t know “whether these items were ever returned to the government upon Clinton’s departure from the State Department.”

4) Filegate: FBI files on GOP enemies

The Clinton duo was involved in a scandal known as “Filegate” in which they illegally obtained FBI files on perceived adversaries, most of whom served in previous Republican administrations.

“In an effort to discredit the women who charged President Clinton with sexual misconduct, personal files and papers were illegally obtained and released. The courts found, under the Privacy Act, that the privacy of Linda Tripp and Kathleen Willey had been violated,” a Judicial Watch report said, citing just a few of more than 900 relevant files. Judicial Watch said Hillary had been linked “directly to the center” of the controversy.

The scandal was first detected by the House Government Reform and Oversight Committee, which investigated the Clintons’ Travelgate caper. The committee found that the FBI files had been improperly accessed by Craig Livingstone, a former bar bouncer Hillary had hired to work in the White House Counsel’s Office. However, Hillary called the whole affair a “completely honest bureaucratic snafu.”

5) ‘Clinton U’ scam

In June, WND reported that a Clinton-backed, for-profit college, Laureate Education’s Walden University, has been called a scam that piles tens of thousands of dollars of debt on unsuspecting students while unreasonably delaying degrees or often failing to deliver them.

In fact, Laureate Education paid \$16 million to Bill Clinton to be the group's pitchman while the State Department funneled \$55 million to Laureate when Hillary was secretary of state.

Bill Clinton abruptly resigned from his post as "honorary chancellor" in April 2015 when the disclosure was publicized.

Documents uncovered by Washington-based watchdog Judicial Watch show Laureate Education paid the former president through a "shell corporation" pass-through account that evidently passed State Department scrutiny while Hillary was secretary of state.

Further, in a story showing how for-profit colleges encourage huge student debt, Forbes found the biggest borrower on the for-profit college list is Laureate Education's Walden University, whose grad students borrowed \$756 million in 2014.

6) Sensitive intel? No experience necessary

Hillary appointed a Clinton Foundation donor and top bundler for Clinton campaigns to a sensitive State Department intelligence advisory board – regardless of the fact he had zero experience.

Fellow board members on the International Security Advisory Board were left puzzled because they couldn't figure out why Rajiv K. Fernando, who had no government intelligence background, would have been named to the panel in the first place.

ABC News cited emails that showed how Hillary's cronies, when questioned about the appointment, sought to "protect the name" of their boss by "stall[ing]" the reporter who sought answers.

Two days after the press inquiry from ABC came, Fernando resigned from the board.

ABC News reported: "Fernando's only known qualification for a seat on the International Security Advisory Board was his technological know-how. The Chicago securities trader, who specialized in electronic investing, sat alongside an august collection of nuclear scientists, former cabinet secretaries and members of Congress to

advise Hillary Clinton on the use of tactical nuclear weapons and on other crucial arms control issues."

Fernando's background also included travel with former President Bill Clinton to Africa and frequent fundraising for Democratic Party candidates.

Fernando raised more than \$100,000 for Clinton's run for the White House in 2008, which she lost to then-Sen. Barack Obama. He also gave between \$100,000 and \$250,000 to the Clinton Foundation, and another \$30,000 to WomenCount, a group that supported Hillary for president in 2008.

7) Hillary's 'Muslim Brotherhood princess'

Huma Abedin, who served as Hillary's longtime deputy chief of staff and is vice chairwoman of Hillary's campaign, has worked with Hillary for nearly 20 years. In fact, Abedin, whom Hillary once called her "second daughter," had direct access to classified national security information stored on Hillary's unsecured email server.

Abedin has known ties to the Muslim Brotherhood – a group bent on "destroying Western civilization from within" – and other Islamic supremacists. As WND has extensively reported, the Muslim Brotherhood and Islamic supremacist connections not only extend to Abedin's mother and father, who are both deeply tied to al-Qaida fronts, but to Abedin herself.

As WND reported, a manifesto commissioned by the ruling Saudi Arabian monarchy places the work of an institute that employed Abedin at the forefront of a grand plan to mobilize U.S. Muslim minorities to transform America into a Saudi-style Islamic state, according to Arabic-language researcher Walid Shoebat.

Abedin was an assistant editor for a dozen years for the Journal of Muslim Minority Affairs for the Institute for Muslim Minority Affairs. The institute – founded by her late father and currently directed by her mother – is backed by the Muslim World League, an Islamic organization in the Saudi holy city of Mecca that was founded by Muslim Brotherhood leaders. The 2002 Saudi manifesto shows that "Muslim

Minority Affairs” – the mobilizing of Muslim communities in the U.S. to spread Islam instead of assimilating into the population – is a key strategy in an ongoing effort to establish Islamic rule in America and a global Shariah, or Islamic law, “in our modern times.”

WND reported Abedin also was a member of the executive board of the Muslim Student Association, which was identified as a Muslim Brotherhood front group in a 1991 document introduced into evidence during the terror-financing trial of the Texas-based Holy Land Foundation.

At her father’s Saudi-financed Islamic think tank, WND reported, Abedin worked alongside Abdullah Omar Naseef, who is accused of financing al-Qaida fronts. Naseef is deeply connected to the Abedin family.

WND was first to report Huma’s mother, Saleha Abedin, was the official representative of Naseef’s terror-stained Muslim World League in the 1990s. Less than one month after the Sept. 11, 2001, terror attacks, Newsweek reported that the Muslim World League was used by terror mastermind Osama bin Laden to finance his operations.

Shoebat previously reported that as one of 63 leaders of the Muslim Sisterhood, the de facto female version of the Muslim Brotherhood, Saleha Abedin served alongside Nagla Ali Mahmoud, the wife of Muslim Brotherhood figure Mohammed Morsi, Egypt’s now ousted president.

Saleha Abedin and Morsi’s wife both were members of the Sisterhood’s Guidance Bureau, Shoebat found.

8) Vince Foster’s 1993 death

Vince Foster was deputy White House counsel and Hillary’s friend and law partner who had connections to the Travelgate and Whitewater scandals. In 1993, Foster was found dead in a park with a fatal gunshot wound to his mouth. As WND reported, his suicide was the subject of much speculation and three official investigations.

Investigations by the U.S. Park Police, the Department of Justice, the FBI, Congress, Independent Counsel Robert B. Fiske and Independent Counsel Kenneth Starr concluded Foster’s death was a suicide. However, as WND reported in 2003, one of Starr’s key investigators challenged the official line, insisting the probe’s result was predetermined, only a few plotters were required to engineer the result, the crime scene was altered and that major newspaper editors killed stories by reporters pursuing the truth. The Washington Post reported that federal investigators were not allowed to enter Foster’s office after his death, but “White House aides enter[ed] Foster’s office shortly after his death, giving rise to speculation that files were removed from his office.”

In his 2005 book “The Truth about Hillary: What She Knew, When She Knew It, And How Far She’ll Go to Become President,” Edward Klein wrote of Hillary’s involvement in the effort to remove Foster’s files:

The night of [Foster’s] death, Hillary launched one of the most shameful – and illegal – cover-ups of her entire career.

She sent two of her most trusted White House loyalists – Maggie Williams, the First Lady’s chief of staff, and Patsy Thomasson, who was in charge of White House administration – into Foster’s office to retrieve embarrassing and incriminating documents related to Whitewater and Hillary’s other personal affairs. While White House Counsel Bernard Nussbaum barred investigators from entering Foster’s office, Maggie Williams, Patsy Thomasson, and Craig Livingston, Hillary’s director of White House security, removed armloads of files and loose-leaf binders.

“In addition, a White House staffer allegedly tampered with the titles of several memos and

removed the first lady's initials in an effort to erase her role in improper behavior.”

9) Emailgate: ‘She should go to prison for this’

As WND reported, Hillary kept all her official correspondence as secretary of state, as well as her personal emails, on a private email server located at her home – instead of using the government-mandated process while serving in the high appointed position. Her email system was unsecured for months while she used it for government business, and she did not sign a standard agreement when she left office that promised she had left government property behind.

The Hill reported Hillary did not encrypt her private email service with a digital certificate for the first three months of her tenure as secretary of state.” That was while she was traveling to China, Egypt, Israel, Japan and South Korea.

Several present and former members of the U.S. intelligence community said Hillary's private email server was a major security risk, and America, going forward, ought to assume enemies of the state all had access to it.

“The name Clinton right on the email handle meant this was not a difficult find,” said John Schindler, a former National Security Agency counterintelligence officer, Investors Business Daily reported.

J. Michael Waller – a longtime consultant to government entities ranging from the secretary of defense to the U.S. Senate to the U.S. Marine Corps Warfighting Laboratory – told WND the Russians hack into the U.S. government, and so does any foreign intelligence worth its salt, most likely through Hillary's private server. Waller said Hillary deserves prison time for insisting on an email system that clearly left the nation vulnerable to attack.

“This is the national-security equivalent of drunken driving,” he said. “She should go to prison for this. When you drink and drive, you know in advance that you're putting other people in danger. Yet, you think because you're so smart or so clever or just don't care, that nothing's going to happen and then something

does, so it's your fault. This is precisely what she did on the national security sphere.”

Hillary gave 55,000 emails from her private email account to the State Department in December 2014. On March 10, 2015, Clinton announced she had deleted 30,000 emails she considered personal. She was warned by Congress way back in 2012 against using a private email account for government business – and her response? Silence.

Fast-forward to July 5, 2016: FBI Director James Comey announced his decision not to recommend charges against Hillary over her handling of classified information because there was no “intent,” which is not a necessity for prosecution.

But on Oct. 28, 2016, just 11 days before Election Day, Comey announced the FBI was reopening the investigation in a letter to Congress. He revealed that the agency “learned of the existence of emails that appear to be pertinent to the investigation.” A total of 650,000 emails were located during the federal probe into former Rep. Anthony Weiner's sexting of a 15-year-old girl.

10) Chinagate: Sale of high-tech secrets

Chinagate, documented by Judicial Watch, was uncovered by Judicial Watch founder Larry Klayman. Technology companies allegedly made donations of millions of dollars to various Democratic Party entities, including President Bill Clinton's 1996 re-election campaign, in return for permission to sell high-tech secrets to China.

Bernard Schwartz and his Loral Space & Communication Ltd. later allegedly “helped China to identify the cause of [a rocket failure], thereby advancing China's missile program and threatening U.S. national security,” according to records.

In a 2013 column titled “Proof Hillary isn't fit to be president,” Klayman wrote:

Not to be outdone by her prior scandals, Hillary ... masterminded a scheme whereby the Clinton-Gore presidential campaign of 1996 took bribes from communist Chinese banks and their

government to bankroll the president's and the Democratic Party's re-election efforts when it appeared, due to their low standing in the polls, that all the stops needed to be pulled out. It was the lawsuit that I brought against Secretary of Commerce Ron Brown, where at Hillary's instruction, he literally sold seats on Department trade missions to China and elsewhere, which principally uncovered this. In late 1996 and early 1997, the scandal had burgeoned to such a level that joint congressional hearings were empaneled, ultimately to be shut down when Democrats uncovered illegal fundraising by some Republicans. The two parties, faced with mutual assured destruction, simply took an exit stage left. However, I soldiered on with my lawsuit. And, while I uncovered a lot about Bonnie and Clyde and their Chinese 'friends,' this scandal ultimately took back seat to the Monica Lewinsky scandal, since the media preferred sex to foreign espionage and graft. Hillary and Bill were ironically saved by Monica, who became the lightning rod drawing attention away to what at the time was perhaps the biggest scandal – Chinagate – in American history.

In fact, new reports indicate China may have accessed all of Hillary's unsecured emails. And in yet another revelation, Fox News reported, "An unnamed 'senior aide' to then Secretary of State Hillary Clinton left classified information unsecured and unattended in a hotel room during a 2010 trip to China, one of several overseas lapses ..."

State Department spokesman John Kirby told Fox, "In May 2010, Secretary Clinton was on official travel in Beijing, China, accompanied by senior staff. Upon Secretary Clinton's departure, a routine security sweep by Diplomatic Security agents identified classified documents in a staff member's suite." The discovery was made during an FBI investigation into whether Hillary and her staff violated the Espionage Act when she improperly handled classified and top-secret information.

11) Travelgate: Always room for friends

In the Travelgate scandal, the staff of the White House travel office was fired to make way for Clinton cronies, including Bill's 25-year-old cousin, who was reportedly promised the position of office director.

Hillary allegedly fired seven employees and gave the positions to her Arkansas friends. According to the Washington Post, there was an effort to award a White House airline contract to a Clinton friend.

Also, Hillary reportedly had the FBI investigate the former head of the travel office, Billy Dale, who was fired without notice and removed from White House grounds. Dale was charged with embezzlement but found not guilty of the crime in 1995. He was later audited by the IRS.

12) Whitewater: Jail for friends, but not Clintons

The Whitewater investigation by independent counsel Kenneth Starr began in 1994 with accusations of impropriety against the Clintons and others concerning improper campaign contributions, political and financial favors, and tax benefits. Its initial subject was a failed Arkansas real-estate venture involving the Clintons in the 1980s that was linked to the collapse of Madison Guaranty Savings and Loan, a Little Rock savings bank run by the Clintons' Whitewater business partners. Clinton friends James and Susan McDougal went to jail for fraud (James died while serving his sentence), as did former Arkansas Gov. Jim Tucker and municipal judges David Hale and Eugene Fitzhugh.

The probe eventually expanded to include the death of deputy White House counsel Vincent Foster, the dismissal of White House travel office employees, receipt by the White House of a number of FBI files and the issue of whether President Clinton lied or obstructed justice to hide an affair with White House intern Monica Lewinsky.

13) 'Landing under sniper fire' in Bosnia

In her March 17, 2008, foreign-policy speech on Iraq, then-Sen. Hillary Clinton recalled a trip she made to Tuzla, Bosnia, in 1996.

"I remember landing under sniper fire," Hillary said of her visit while she was first lady. "There was supposed to be some kind of a greeting ceremony at the airport, but instead we just ran with our heads down to get into the vehicles to get to our base."

But news footage of her visit revealed her “sniper fire” claim wasn’t just exaggerated. It was completely false. And Hillary had repeated the claim several times, including during her time on the presidential campaign trail in 2007.

Rather, Hillary landed on a tarmac and greeted a crowd, including an 8-year-old child who gave her a poem, under no duress. According to the Washington Post, a review of more than 100 news articles revealed no security threats to Hillary at the time.

After the 2008 speech, Hillary was asked about her statements, and she stood by them: “There was no greeting ceremony, and we basically were told to run to our cars. Now that is what happened.”

But, a week later, Hillary told the Philadelphia Daily News that she “misspoke.” Hillary claimed she had been told there was a threat of sniper fire in the area.

The following day, she declared: “So I made a mistake. That happens. It shows I’m human, which for some people is a revelation.”

14) Hillary’s ‘missing’ law firm billing records

In 1994, federal investigators subpoenaed Hillary’s billing records from her days as a partner in the Rose Law firm during the Watergate scandal. The White House said it didn’t have the 115 pages of files.

While Hillary claimed she had a minor role in the affair, the Washington Examiner reported that “when the records mysteriously turned up in the White House in 1996, they showed she met repeatedly with key figures in the scandal.”

15) Hillary’s secret speeches

Since they left the White House, the Clintons have raked in millions of dollars giving speeches. Hillary spoke to banks such as Goldman Sachs and Morgan Stanley. In fact, as WND reported, she received more than \$21 million in just two years for giving speeches to large banks and corporations.

But, despite relentless requests from many reporters, Hillary refused to release the transcripts of her speeches or information about where she and Bill spoke and what they charged.

It’s also still unclear which fees were pocketed by the Clintons as income and which were designated as funds going to charity through the Clinton Foundation.

The New York Post reported that from April 2013 to March 2015, Hillary “collected \$21,667,000 in ‘speaking fees,’ not to mention the cool \$5 mil she corralled as an advance for her 2014 flop book, ‘Hard Choices.’ Throw in the additional \$26,630,000 her ex-president hoovered up in personal-appearance ‘honoraria,’ and the nation can breathe a collective sigh of relief that the former first couple – who, according to Hillary, were ‘dead broke’ when they left the White House in 2001 with some of the furniture in tow – can finally make ends meet.”

Talk-radio host Rush Limbaugh reacted to the Post’s report, declaring, “I think this is shocking.”

“I’m telling you, folks: \$21 million over two years for 20 or 25 minutes? There’s nothing that screams ‘out of touch’ more than that.”

In October, WikiLeaks released excerpts of Hillary’s closed-door remarks to Goldman Sachs and other financial firms. Some of the revelations include:

- Hillary Clinton was so enraged that Bill Clinton was forced to cancel a paid speech at Wall Street bank Morgan Stanley in 2015 that she “needed a cool down period.” The email chain, on March 11, 2015, before she formally launched her campaign, includes top aides to both Hillary Clinton and former President Clinton, and reveals that Hillary’s future campaign aides were concerned about the political impact of Bill giving a speech to a Wall Street bank. “Morgan Stanley is coming down,” wrote Robby Mook in an email to top Clinton aides. Top aide Huma Abedin explained that Hillary would not be happy about it, writing: “HRC very

- strongly did not want him to cancel that particular speech. I will have to tell her that [Bill] chose to cancel it, not that we asked.”
- Hillary Clinton’s paid speeches to Goldman Sachs and other financial firms, a point of contention during this year’s primary, were the subject of an email to John Podesta. Excerpts from some of the speeches had been flagged by Clinton’s research team, including the necessity of having “both a public and a private position” on issues. It was just part of “making sausage” in the political arena, she said, that certain positions on issues needed to be kept hidden from the public.
 - Some “flags” in Hillary Clinton’s paid speeches were noted in a Jan. 25 email from campaign research director Tony Carrk to top Clinton advisers, including Clinton’s declaration that “My dream is a hemispheric common market, with open trade and open borders, some time in the future with energy that is as green and sustainable as we can get it, powering growth and opportunity for every person in the hemisphere.” Countless establishment media outlets parlaying themselves as “fact checkers” tried to downplay this email by saying it was “mostly about trade,” not immigration, as if the words “open borders” were never mentioned. But the email exchange also shows how Hillary’s about-face on the TPP trade deal was mere pandering to Bernie Sanders’ voters and had no basis in reality in terms of how she really feels about trade deals.
 - In a speech at Goldman-Black Rock on Feb. 4, 2014, Carrk pointed out, Clinton admitted she’s “Kind Of Far Removed” from middle-class struggles due to “The Economic, You Know, Fortunes That My Husband And I Now Enjoy.” Clinton, in other speeches, boasted of her ties to Wall Street, an issue primary opponent Bernie Sanders continually raised. Clinton still has refused to release transcripts of her paid speeches

while blasting Donald Trump for not releasing his tax returns.

- Clinton also told Goldman Sachs bankers that Americans who want to limit immigration are “fundamentally un-American.

16) Pardongate: Hillary Senate contributions

Before Bill Clinton left the White House in 2001, he granted numerous controversial pardons – including to convicted tax evader Marc Rich, whose wife made significant contributions to Hillary’s 2000 Senate campaign and the Clinton presidential library.

The Associated Press reported that Rich had been “indicted by a U.S. federal grand jury on more than 50 counts of fraud, racketeering, trading with Iran during the U.S. Embassy hostage crisis and evading more than \$48 million in income taxes – crimes that could have earned him more than 300 years in prison.” Rich fled to Switzerland in 1983 after his indictment and remained on the FBI’s Most Wanted List until President Clinton pardoned him.

Also, Hillary’s brothers, Tony and Hugh Rodham, reportedly received large amounts of money from people who were pardoned by Bill Clinton. Hillary said she and Bill were unaware of the scheme.

Accuracy in Media reported, “Hugh Rodham, Hillary’s brother, was taking money and promising access to help get pardons. Two such high profile cases were those of drug kingpin Carlos Vignali and convicted swindler Glenn Braswell. Rodham received hundreds of thousands of dollars from each, and they were both granted pardons. Rodham was quoted as telling a top White House aide that the pardon for Vignali was ‘very important’ to Hillary.”

17) Hillary’s cash cows and 9,987 percent profit

In March 1994, it was revealed Hillary – with no previous experience – had made massive profits from cattle futures trading between 1978 and 1979, when Bill Clinton’s salary as Arkansas attorney general had been modest. She reportedly made \$99,537 in profit on a \$1,000 investment (a

9,987 percent profit) in just nine months because of a highly placed connection at Tyson Foods, which was the largest employer in Arkansas and a big Clinton donor.

The New York Times reported: “During Mr. Clinton’s tenure as Governor, Tyson benefited from several state decisions, including favorable environmental rulings, \$9 million in state loans, and the placement of company executives on important state boards. ... The commodities trades were the most successful investment the Clintons ever made. The nearly \$100,000 profit enabled them to buy a house, invest in securities and real estate and provide a nest egg for their daughter, Chelsea.”

18) Clinton body count: ‘You find dead people’

“The Clinton body count,” first published in WND and later circulated by Linda Tripp to Monica Lewinsky, is a collection of names of people associated with Clinton administration scandals who have died mysterious and often violent deaths. Reporter David Bresnahan broke the story of the list during the summer of 1997 while researching his book, “Cover Up: The Art and Science of Political Deception.”

“I started looking into all the various deaths of people that were involved in various Clinton scandals,” Bresnahan said. “I started to investigate the entire picture instead of just one focused event.

“Nobody out there was putting it all together,” he said. “If you look at one scandal, you’ll find one dead guy. When you investigate all Clinton scandals, you find similarities, you find common tactics, you find common actions and you find dead people.”

The list was not just a source of terror among sworn enemies of the administration. It was an even greater terror for those close to Clinton – for those closest, it appeared, died younger and more inexplicably than those on the outside looking in.

In his research, Bresnahan came up with more than one list.

“Not only did I find a list of dead people, but I also found that there are over 100 people who have refused to testify,” he said at the time.

“There is also a list of people who have gone to jail. There are 45 people who have gone to jail, some of them White House staff, Cabinet members as well as people from the Justice Department. So many of those (lists) developed when I started to pursue the big picture.”

In August, WND compiled a list of 33 people associated with the Clintons who have died the most mysterious and often violent deaths.

Notably, the largest number of mysterious deaths occurred during the most intense years of the Whitewater investigation, from 1993 (when Clinton’s first term as president began) to around 1996 (the year the Senate Whitewater committee finished its investigation).

19) Hillary’s radical pal, Saul Alinsky

As WND has reported, the exact nature and extent of Hillary’s relationship with radical community organizer Saul Alinsky has long been the subject of speculation and intrigue. The interest has been largely fueled by her suppressed and later released 92-page senior thesis for Wellesley College offering an extensive, largely positive critique of Alinsky and his work.

WND recently found that long after Alinsky’s death in June 1972, a group Clinton co-chaired maintained a working relationship with Alinsky’s main community organizing outfit, the Industrial Areas Foundation, or IAF.

The partnership extended into the 1990s and yielded influence over the education policy of the Clinton presidency. Dick Morris, a former top political adviser to Bill Clinton both as governor of Arkansas and as president, noted to WND that education reform “is the key issue Hillary Clinton used to propel herself independently to the forefront of Arkansas politics during Bill’s governorship.”

“The revelation of how closely linked her efforts were back in the 80s – and have been since – to an Alinsky radical front group is deeply disturbing and expands our understanding of

Hillary's fundamental radicalism and commitment to the new left of Saul Alinsky," Morris said.

Hillary was said to have met with Alinsky several times in 1968, when she was writing her thesis. In her most recent memoir, Hillary wrote that she rejected a job offer from Alinsky to instead attend law school.

The Hillary-Alinsky relationship received more media attention last September, when the Washington Free Beacon uncovered direct correspondence between Clinton and Alinsky from the archives of Alinsky's IAF. The correspondence dates to the summer of 1971, when the 23-year-old Clinton was living in Berkeley, California, and interning at the law firm Treuhaff, Walker and Burnstein. In a July 8, 1971, letter to Alinsky marked "personal," Hillary wrote: "Dear Saul, When is that new book [Rules for Radicals] coming out – or has it come and I somehow missed the fulfillment of Revelation?"

"I have just had my one-thousandth conversation about Reveille [for Radicals] and need some new material to throw at people," she wrote, referring to a 1948 Alinsky treatise on community organizing.

The Free Beacon's Alana Goodman noted the letter documents Hillary and Alinsky had kept in touch since she entered Yale and that Alinsky even offered her advice on campus activism.

Hillary wrote that she missed their regular conversations and asked if Alinsky would be able to meet her the next time he was in California.

"I am living in Berkeley and working in Oakland for the summer and would love to see you," she wrote. "Let me know if there is any chance of our getting together."

20) Hillary laughs about defending child rapist

Hillary Clinton in 1975, the year she defended 41-year-old Thomas Alfred Taylor, who had been accused of raping a 12-year-old child

As WND reported, Hillary explained her defense of a child-rape suspect as just part of the job. But she hasn't explained her laughing about his passing of a lie-detector test, which "destroyed" her faith in such evaluations.

"Once I was appointed I fulfilled that obligation," she said in an interview with Mumsnet, a U.K. community of parents providing and sharing information on a variety of subjects and issues.

In the video she is asked, "As a lawyer, you defended the rapist of a 12-year-old girl, calling the victim 'emotionally unstable' and saying that girls have a tendency to 'exaggerate or romanticize sexual experiences especially when they come from disorganized families.'"

Clinton said: "When I was a 27-year-old attorney doing legal aid work at the law school where I taught in Fayetteville, Arkansas, I was appointed by the local judge to represent a criminal defendant accused of rape. I asked to be relieved of that responsibility. But I was not and I had a professional duty to represent my client to the best of my ability, which I did.

"He later pled guilty to a lesser included offense. When you're a lawyer you often don't have the choice as to who you will represent, and by the very nature of criminal law there will be those who you represent you don't approve of, but at least in our system, you have an obligation and once I was appointed, I fulfilled that obligation."

However, she did not address the reports of unearthed recordings in which she almost boasts of knowing of her client's guilt and laughing about the case. The tapes reveal her discussing the case of Thomas Alfred Taylor, then 41, who was accused of raping a 12-year-old in Springdale, Arkansas, on May 10, 1975.

"It was a fascinating case, it was a very interesting case," Clinton said on the tape. "This guy was accused of raping a 12-year-old. Course he claimed that he didn't, and all this stuff. ... I had him take a polygraph, which he passed – which forever destroyed my faith in polygraphs." She laughed at the statement.

The Washington Free Beacon report on the recordings also confirmed she was laughing

several other times while discussing the case, including “when discussing the crime lab’s accidental destruction of DNA evidence that tied Taylor to the crime.”

Published profiles of the case reveal that Clinton’s strategy at the time was to attack the 12-year-old. She submitted an affidavit that said she was told the girl was “emotionally unstable” and was viewed as having a “tendency to seek out older men and engage in fantasizing.” She claimed the child “in the past made false accusations” and she exhibited “an unusual stubbornness and temper when she does not get her way.”

The woman who says she was raped by the defendant blasted Hillary in 2014, accusing her of intentionally lying about her in court documents. “Hillary Clinton took me through hell,” she told the Daily Beast.

21) Hill ca\$hes in: Iranian fundraising

As WND reported, Hillary received funds from an arm of the Iranian government and hired a convicted Iranian-American multimillionaire with ties to Tehran as her national campaign finance director in 2008. The Bill, Hillary, and Chelsea Clinton Foundation accepted \$30,000 between April 2005 and March 2006 and another contribution of between \$25,000 and \$50,000 in 2008 from the New York-based Alavi Foundation, which U.S. government prosecutors have identified as an arm of the Iranian government.

For her 2008 presidential campaign, Clinton hired Hassan Nemazee as her national campaign finance director, who was known for his efforts to normalize relations with the theocratic Iranian regime. In 2010, Nemazee pleaded guilty to running a Ponzi scheme in which he obtained \$292 million in fraudulent loans. He was sentenced to 12 years in prison.

Rachel Ehrenfeld, director of the American Center for Democracy, spelled out the problem with the Clinton Foundation receiving funds from the Alavi Foundation in a Jan. 5, 2009, article published by Forbes.

“Alavi’s contribution [in 2008] to Clinton came just two days after the Treasury Department also

designated Alavi’s partner, the New York-based Assa Corp., as a terrorist entity, and the New York Southern District’s attorney seized and forfeited its assets,” Ehrenfeld wrote.

22) Clinton Foundation: Scandals keep coming

As WND reported, the Clintons appear to have siphoned off tens of millions of dollars annually from funds the Bill, Hillary, and Chelsea Clinton Foundation has received from a United Nations-sponsored program that uses levies on airline tickets to help HIV/AIDS victims in the Third World, charges Wall Street analyst and investor Charles Ortel. The Clinton Foundation also reportedly distributed useless drugs to AIDS patients in Third-World countries.

The Clinton Foundation was initially established and granted IRS federal tax-exempt status to build a presidential library in Little Rock, Arkansas. However, it was soon used for other purposes as well, even though it had no authorization to collect charitable donations for any purpose other than the library’s construction.

One such purpose was ostensibly combating HIV/AIDS in the Third World. However, the Clinton Foundation illegally diverted more than \$75 million in UNTAID funds from their intended purpose, which was to prevent, treat and diagnose HIV/AIDS, tuberculosis and malaria in Third World countries. That money likely went to the Clintons’ personal use.

Further, the Clintons arranged to buy defective generic drugs for Third World AIDS patients, and they appear not to have followed through to make sure those drugs actually reached AIDS patients and made a difference in the fight against HIV.

Another purpose for which the Clintons used their foundation was earthquake relief in India following a devastating 2001 quake in the western part of the country. Bill Clinton helped establish the American India Foundation to assist India, but he subsequently diverted substantial funds to himself and his cronies.

Moreover, the AIF was not even registered in many states as a nonprofit organization with

authority to raise charitable donations, although it raked in millions of dollars in those states.

Although Hillary was appointed to the board of directors of the Clinton Foundation in 2013, after she had resigned as secretary of state, Ortel contends she is complicit in what he has described as systematic financial fraud warranting a criminal investigation.

After months of tedious investigation, Ortel concluded the foundation filed financial and tax forms that were materially misleading, incomplete and in error with the goal of enriching the Clintons and their close associates. Ortel alleged Hillary advanced an “inurement” scheme – enriching oneself through a nonprofit organization – in complicity with her husband by positioning various key associates within the Clinton Foundation structure while she served as U.S. senator from New York and subsequently as secretary of state under President Obama.

“Ongoing analysis of legally required public disclosures reveals that while Mrs. Clinton served as director, the Clinton Foundation and its principal constituent elements, filed false and materially misleading tax returns with the IRS and with other governmental authorities, for multiple years,” Ortel charged in his second report on alleged Clinton Foundation mismanagement.

As WND also reported, based on Ortel’s findings, a prominent lawyer and a top government watchdog in the nation’s capital called for the Clinton Foundation to be shut down.

The New York Times reported, “Cash flowed to Clinton Foundation as Russians pressed for control of uranium company.”

Hillary has said, “I am very proud of the work the Foundation does,” but just 9 percent of the Foundation’s money went to charity in 2013. Fox News’ John Stossel noted, “Charity Navigator, the biggest charity rating service, won’t even list the Clinton Foundation in its rankings. This is repulsive. If a Republican candidate ran a charity that did that, it would be a scandal. But the Clintons must be immune.”

WND reported that before Hillary completed her first year as President Obama’s secretary of state, Ortel calculated \$17 million went missing from Clinton Foundation financial reports.

The New York Post reported Hillary’s former chief of staff and counselor, Cheryl Mills, “knows where the bodies are buried” in many Clinton scandals, has been at Hillary’s side since the 1990s and “has a long track record of hiding Clinton documents.” According to the Post, Hillary gave her the job of “identifying and preserving all emails that could potentially be federal records.” The Post added, “And, presumably, deleting.” Mills, who has officially been accused of perjury and obstruction of justice, is a key member of the Clinton Foundation board.

And the Clinton Foundation scandals don’t end there.

As WND reported, a lawsuit has been filed against the State Department demanding information about its cooperation with the foundation, as “pay-for-play” allegations swirl around Hillary from her time as secretary of state. The FBI is looking for evidence Hillary’s State Department granted special treatment to Clinton Foundation donors.

According to new revelations this month reported by Fox News’ Bret Baier:

- The FBI’s investigation into the Clinton Foundation’s pay-for-play interaction with the State Department has been under way for more than a year, and it’s more expansive than previously reported.
- FBI agents are combing through Mills’ laptop and the laptop of Heather Samuelson.
- FBI sources told Baier indictment is “likely” in the case of pay-for-play at the Clinton Foundation, “barring some obstruction in some way” from the DOJ.

23) Benghazi: 4 American lives lost

On Sept. 11, 2012, while Hillary was secretary of state, Islamic militants attacked a U.S. special mission in Benghazi, Libya, and murdered U.S.

Ambassador J. Christopher Stevens and U.S. Foreign Service Information Management officer Sean Smith. Two CIA contractors, Tyrone Woods and Glen Doherty, were also killed.

In the months leading up to the attack, Hillary's State Department cut security in Libya. Sen. Ron Johnson, R-Wis., accused Hillary of "dereliction of duty" that led to the deaths of the four Americans.

"The State Department not only failed to honor repeated requests for additional security, but instead actually reduced security in Libya," Johnson wrote in the *Milwaukee Journal Sentinel*. "Although no one can say with certainty, I firmly believe a relatively small contingent of armed military guards would have prevented the attack, and those four lives would not have been lost."

As WND reported, a security decision finalized personally by Hillary may have unwittingly doomed the Americans in Benghazi. Hillary herself signed waivers that allowed the facility to be legally occupied, since it did not meet the minimum official security standards set by the State Department. The waiver legally allowed the CIA annex to be housed in a location about one mile from the U.S. special mission.

According to accounts from Benghazi survivors, the delayed response time by those at the CIA annex may have cost the lives of Stevens and the three other Americans killed at the special mission. If the CIA annex had been co-located with the U.S. special mission, a rapid response team would have been on site during the initial assault in which Stevens was killed. Clinton's waiver allowed the CIA annex to be housed at the separate location.

As WND also reported, State Department emails show Clinton knew while the attack was under way that it was being carried out by terrorists.

Judicial Watch has obtained previously classified documents from the U.S. Department of Defense and the Department of State revealing that DOD almost immediately reported that the attack on the U.S. Consulate in Benghazi, Libya, was planned and carried out by al-Qaida and Muslim Brotherhood-linked terrorists. A federal court ordered the government hand over more than 100 pages of previously secret documents that

showed then-Secretary of State Hillary Clinton and other senior Obama officials were given reports within hours of the Sept. 11, 2012, attack. In those memos, the DOD described details of a plan 10 days in advance "to kill as many Americans as possible."

Nonetheless, Hillary falsely blamed it on "rage and violence over an awful Internet video" when she spoke at a ceremony at Andrews Air Force Base on Sept. 14, 2012, as the remains of the four Americans were returned to the U.S.

A special, months-long investigation into Benghazi by a select committee concluded just a week ago. Democrats on the House Select Committee on Benghazi issued a 339-page minority report on June 27 concluding that Hillary never denied requests for additional security and accusing seven Republican members of having only political motives in conducting the inquiry. Republicans issued a majority report on their findings on June 28.

As WND reported, Rep. Jim Jordan, R-Ohio, said Hillary began spreading the story of a video triggering the violence even as Navy SEALs were still fighting for their lives.

Jordan explained why the whole scandal happened: "The evidence clearly shows the motive was political concerns that outweighed everything else, including getting planes off the ground in a timely fashion to maybe get there in time to help Tyrone Woods and Glen Doherty."

"Jordan said that while the Obama administration ignored multiple warning signs to either pull out or beef up security, the attack itself threatened one of the Obama-Biden campaign's top talking points, that the U.S. had al-Qaida on the run.

"[Hillary Clinton] was the one who pushed for [Moammar] Gadhafi's ouster a year before. They're doing victory laps. They're saying this is how foreign policy works. No boots on the ground. You can oust a dictator as part of the Arab Spring," Jordan said. "Then they have 13 months of all kinds of violence, all kinds of dangerous situations, assassination attempts on the British ambassador, the security situation deteriorates, and we stay when almost everyone else leaves. And then it happened."

Jordan said a statement from, Hillary went out at 10:08 p.m. Eastern time the night of the attack, blaming the mayhem on a protest over the YouTube video defaming Muhammad.

Yet an hour later, Hillary emailed her daughter, Chelsea, to say it was a terrorist attack.

The next day, Hillary told the Egyptian prime minister via email that the video had nothing to do with it.

“At 10:08, when she issues that statement, Tyrone Woods is still on the roof of the annex, fighting for his life,” Jordan said. “It’s not until an hour and 10 minutes later, approximately 11:15, when the mortars hit the CIA annex building and take the lives of Glen Doherty and Tyrone Woods.

“He’s still fighting. At 10:08, she’s already blaming a video in the official statement from our government that evening. They started the political spin right from the get-go.”

24) Peter Franklin Paul: Another Hillary friend goes to prison

As WND reported, Hillary was named in a lawsuit brought by Peter Franklin Paul for allegedly directing to her 2000 Senate campaign an illegal, in-kind contribution from Paul that included a fundraiser at the exclusive Spago restaurant in Beverly Hills, a tea hosted at the Beverly Hills home of socialite Cynthia Gershman and a lavish, A-list, million-dollar-plus Hollywood gala honoring Bill Clinton. At the trial of Clinton’s finance director for the 2000 senatorial campaign, David Rosen, the government told the jury Paul personally gave more than \$1.2 million to produce the events.

Paul, a former business partner of Spider-Man creator Stan Lee who sued Bill for fraud and accused Hillary of hiding nearly \$2 million in Senate campaign donations, alleged they sabotaged the media company he formed with Lee to get out of a \$17 million agreement made with Bill Clinton to serve as an international promoter for the company after he left the White House. Paul was indicted in June 2001 for manipulating the price of the stock in his company, Stan Lee Media, as it was collapsing. A judge determined Paul didn’t profit from the

attempt to save his company, but he accepted a plea bargain and served three years in prison. WND reported in 2012 that Paul charged Attorney General Eric Holder and his Justice Department obstructed justice by renegeing on a sentencing agreement.

“Hillary is carrying out her promise to finally destroy my family to punish me for exposing the corruption that elected her to the Senate,” Paul told WND at the time.

The Clintons were effusive in their praise of Paul until just days after an August 2000 Hollywood gala, when the Washington Post reported Paul’s 1970s criminal convictions in a story that accused the senator of being soft on crime. Clinton continued, however, to quietly solicit money from Paul and sent him letters expressing friendship. Paul has extensive video corroborating his contention he and Hillary spent hours together and sat next to each other at the fundraising events.

25) Watergate: Fired for being a ‘liar’

Hillary actually played a role in the Watergate saga, and her actions as a young attorney may have set the tone for her career.

The 27-year-old Clinton was fired from the staff of the House Judiciary committee investigating the Watergate scandal in 1974. She was fired by her supervisor, lifelong Democrat Jerry Zeifman, who called her a liar and much worse.

“She was an unethical, dishonest lawyer,” he said. “She conspired to violate the Constitution, the rules of the House, the rules of the committee and the rules of confidentiality.”

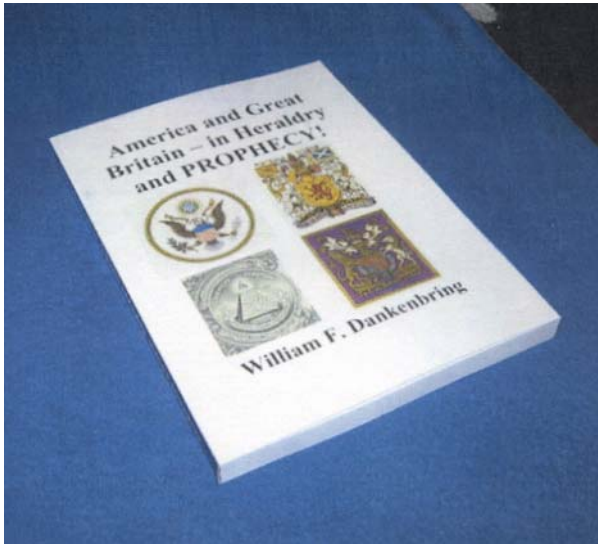
Zeifman also refused to give Clinton a letter of recommendation, making her one of only three employees he snubbed during his 17-year career. (WND, Nov.3, 2016).

This word is derived from the Greek word “apologia,” which means “to defend.” The entire “Clarifying Christianity” website is filled with apologetics—proofs and explanations for many Christian-related issues. The focus of this page is the proof supporting the accuracy of the Bible. After all, if the Bible is not true or if it is filled with errors, Christianity would only be a “blind faith”—something people believe without any evidence to support it.

However, Christianity is *not* a blind faith. It is the *only* religion that can prove itself, and a main source of that proof is the Bible.

Fulfilled Prophecy Proves the Bible Inspired!

Fulfilled prophecy is the fourth proof of the inspiration of the Bible—accurately foretelling what will happen ahead of time. The Bible is unique in boldly proclaiming many specific events to come. No other religious book dares to lay out the future in this way.

As the book *A General Introduction to the Bible* says: “No unconditional prophecy of the Bible about events to the present day has gone unfulfilled . . . Other books claim divine inspiration, such as the Koran, the Book of Mormon, and parts of the [Hindu] Veda. But none of those books contains predictive prophecy.

As a result, fulfilled prophecy is a strong indication of the unique, divine authority of the Bible.” So say Norman Geisler and William Nix, *A General Introduction to the Bible* 1986, p. 13).

Fall of Ancient Babylon

Isaiah was a prophet who began to prophesy the year that King Uzziah of Judah died, which was around 740 B.C. (Isaiah 6:1, 8). One of his predictions was about the city Babylon.

In the Bible, Isaiah 13:1 says, “The burden against Babylon which Isaiah the son of Amoz saw.” At the time of Isaiah’s prediction, Babylon was one of the largest and most important cities in the world. This is what God told Isaiah would happen to Babylon:

Isaiah claimed that God told him that Babylon would be completely destroyed.

“Behold, I will stir up the Medes against them, who will not regard silver; and as for gold, they will not delight in it. Also their bows will dash the young men to pieces, and they will have no pity on the fruit of the womb; their eye will not spare children. And Babylon, the glory of the kingdoms, the beauty of the Chaldeans’ pride, will be as when God overthrew Sodom and Gomorrah. It will never be inhabited, nor will it be settled from generation to generation; nor will the Arabian pitch tents there, nor will the shepherds make their sheepfolds there” (Isaiah 13:17-20).

Isaiah claimed that God told him that Babylon would be completely destroyed.

The Assyrians Destroy Babylon

During Isaiah’s lifetime, the Assyrian Empire ruled most of the Middle East. The Assyrians controlled many foreign cities, including Babylon. After Isaiah made his prediction, Babylon rebelled against the Assyrians several times. When Sennacherib, king of the Assyrians, captured the city in 689 B.C., he decided to destroy the city forever so that it could never rebel again. Sennacherib made this inscription about his victory:

“I made its destruction more complete than by a flood. That in days to come the site of that city, and (its) temples and gods, might not be remembered, I completely blotted it out with (floods) of water and made it like a meadow” (Daniel D. Luckenbill, *Ancient Records of Assyria and Babylonia*, 1926-1927, Vol. 2, p. 152).

Isaiah’s prophecy was not fulfilled when Sennacherib destroyed Babylon. Isaiah predicted that the Medes would attack Babylon. But it was the Assyrians who attacked and destroyed the city first.

When Isaiah wrote his prediction, the Medes were weak. Most of the Medes were ruled by other nations, and the remaining Medes were not unified (*The Cambridge History of Iran*, 1985, Vol. 2, p. 80). It would have been impossible for them to capture or destroy the strong city of Babylon. Isaiah’s prediction appeared to be wrong. When the Assyrians destroyed Babylon in 689 B.C., Isaiah’s prediction appeared to be completely impossible. The Medes could not fight against a city that was gone!

Babylon Rebuilt

Sennacherib thought that he had destroyed Babylon forever. But after Sennacherib died, his son Esarhaddon began to rebuild Babylon. Soon Babylon became an important city in the Assyrian Empire like it had been before.

In 626 B.C., Babylon rebelled against Assyria again. This time the Babylonians were successful. A local leader, Nabopolassar, became the king. He was able to establish Babylonia as a separate kingdom and Babylon began to grow in strength.

The Medes were also growing in strength at this time. Media managed to become independent from Assyria and expel the armies of the Scythians that had invaded their country (Herodotus 1.95, 106). In 612 B.C. the king of Media and the king of Babylon formed an alliance and fought together against Nineveh, the last capital city of Assyria. They captured the city and burned it. Within a few years the Babylonians and Medes had completely destroyed the Assyrian Empire. The Babylonians took most of the former Assyrian lands, and the Medes took what remained.

By 605 B.C., when Nebuchadnezzar became king of Babylon, the Babylonian Empire had become the leading empire in the world. Nebuchadnezzar focused on expanding his empire and on expanding Babylon to become the greatest city in the world. He built a beautiful palace, rebuilt and repaired the walls, improved the city streets and embellished the temples.

When Nebuchadnezzar died in 562 B.C., Babylon was truly one of the most magnificent cities in the world. Isaiah had predicted that God would destroy Babylon—but now Babylon was greater than it had been in Isaiah's lifetime. However, Babylon's greatness would not last forever.

Enter the Medes

A few years later, in 559 B.C., Cyrus the Great became king over Persia, a region under the rule of Media. The Persians were a tribe of people closely related to the Medes. Cyrus' father was a Persian prince, and his mother was the daughter of the king of Media (Herodotus 1.107, 122). In about 550 B.C. Cyrus overthrew his grandfather, the king of Media, and became the king of both Media and Persia. Cyrus quickly began to build an empire. In 546 B.C. he conquered the Greek kingdom of Lydia (in western Turkey). In 539 B.C., Cyrus' army came to fight against Babylon.

Babylon was a very strong city. Two thick walls and a large moat protected the city, making it extremely difficult for an enemy to attack. However, Babylon was divided into two parts. The larger part of the city was built on the east bank of the Euphrates River, and a smaller part of the city was on the west bank of the river. Babylon had strong walls, but it also relied on the Euphrates River and the moat around the city to protect it.

The Greek historian Herodotus, who wrote about Babylon about 100 years later, described how Cyrus' army captured the city. Part of the army went north of Babylon and dug a trench from the Euphrates River to a nearby marsh. When the army connected the trench to the Euphrates River, much of the water in the river flowed toward the marsh, while only a little water continued to flow toward Babylon. While the Babylonians were confidently celebrating a feast, the strong river and moat protecting the city became very shallow, and the Medes and Persians were able to enter the city (Herodotus 1.191). They captured the city without a battle, and Darius the Mede was put in charge (Daniel 5:31).

Isaiah's Predictions Fulfilled

Today, Babylon is still an empty city. In times of peace tourists can go see the partially rebuilt ruins of Babylon that have remained empty for almost 2,000 years.

Finally, nearly 200 years after Isaiah wrote about Babylon, part of his prophecy was fulfilled. God told Isaiah, "Behold, I will stir up the Medes against them, who will not regard silver; and as for gold, they will not delight in it" (Isaiah 13:17). The Medes captured Babylon, just as Isaiah predicted. They captured the city without a battle and did not plunder the city. However, the other details of the prophecy had not happened yet.

Isaiah said that the Medes would kill many people: "Also their bows will dash the young men to pieces, and they will have no pity on the fruit of the womb; their eye will not spare children" (Isaiah 13:18). This prediction was fulfilled several years later.

An inscription written on a rock cliff in Bisotun, Iran—made by Darius, king of the Medes and Persians—describes the event. In 521 B.C. the Babylonians appointed their own king and the city rebelled. Darius' army defeated the rebel army and captured Babylon. Then the rebel king and his main followers were impaled inside the city.

In about 482 B.C. Babylon rebelled against their Persian and Median rulers again. Xerxes the king sent his army to capture the city. The army destroyed the temples and took away the idol of the Babylonian god Marduk (Arrian, *The Campaigns of Alexander*, 7.17.2; Herodotus 1.183). Xerxes may have also destroyed the outer walls of Babylon.

After this punishment the city began to decline in importance. When Alexander the Great defeated the Persians 150 years later, much of Babylon was still destroyed (Arrian 3.16.4). However, many people still lived in Babylon. Alexander decided to rebuild Babylon's temples and make Babylon a marvelous city again, but he died before he could accomplish his plan.

After Alexander's death, Seleucus I gained control of a large part of the Middle East, including Babylonia. He did not share Alexander's grand vision for Babylon. Instead he built a new city called Seleucia, nearby on the Tigris River. An ancient clay tablet shows that Seleucus' son ordered most of the population of Babylon to move to this new city in 275 B.C. (M.M. Austin, *The Hellenistic World From Alexander to the Roman Conquest*, 1981, p. 241).

After that time Babylon wasn't a major city anymore. About 250 years later the Roman writer Strabo wrote, "Seleucia at the present time has become larger than Babylon, whereas the greater part of Babylon is so deserted that one would not hesitate to say... 'The Great City is a desert'" (Geography, 16.1.5, Loeb Classical Library).

Before long Babylon was completely empty.

In 1899, German archaeologists went to the area in Iraq called Tell Babil, and they began to dig and uncover parts of ancient Babylon. In 1978, the president of Iraq, Saddam Hussein, began to rebuild some of the ancient buildings of Babylon. Some of the temples have been built again and also a palace, some walls and an amphitheater (Amatzia Baram, Culture, History, and Ideology in the Formation of Ba'athist Iraq, 1968-89, 1991, p. 47).

But today, Babylon is still an empty city. In times of peace tourists can go see the partially rebuilt ruins of Babylon that have remained empty for almost 2,000 years. The city is exactly like Isaiah predicted: "It will never be inhabited, nor will it be settled from generation to generation" (Isaiah 13:20).

How could Isaiah know that the Medes, a weak tribe, would grow in strength and conquer the strong city of Babylon almost 200 years later? How could he know that one of the greatest cities in the world would be abandoned and remain empty for thousands of years? No one can make accurate predictions like these. The events in history show that the prophecies in the Bible really did come from God.

Ancient Tyre Destroyed

At the time Ezekiel wrote this prophecy (roughly between 592-586 BC), Tyre was divided into two locations. There was the island of Tyre, which was a well-fortified city located about a half-mile off shore from modern Lebanon, and the mainland city, once called [Ushu](#), which became a suburb of Tyre. The city of Tyre still exists today, but the island and mainland are now connected by an artificial causeway (or land bridge) first constructed by Alexander the Great in 332 BC.

The Biblical "proof of divine inspiration" begins in Ezekiel 26; let's take it verse by verse.

"In the eleventh month of the twelfth year, on the first day of the month, the word of the Lord came to me: "Son of man, because Tyre has said of Jerusalem, 'Aha! The gate to the nations is broken, and its doors have swung open to me; now that she lies in ruins I will prosper,' therefore this is what the Sovereign Lord says: I am against you, Tyre, and I will bring many nations against you, like the sea casting up its waves" (v.1-3).

Tyre was rejoicing over Jerusalem's fall to Babylon, which God apparently found distasteful, so he curses Tyre saying, "I will bring many nations against you."

God goes on, “They will destroy the walls of Tyre and pull down her towers; I will scrape away her rubble and make her a bare rock.⁵ Out in the sea she will become a place to spread fishnets, for I have spoken, declares the Sovereign Lord. She will become plunder for the nations, and her settlements on the mainland will be ravaged by the sword. Then they will know that I am the Lord” (v.4-6).

The island of Tyre was famous for her impressive and impregnable “walls” and “towers.” On the side facing the shore, they were said to be 20’ thick at the base and 150’ high.

It’s crucial to note that the Tyre “out in the sea” refers to the island of Tyre, which was to become “a place to spread fishnets.” In order to accommodate those fishnets, the previous sentence tells us the island would be made bare rock by the pulling down of walls and towers. If there’s any doubt that these two sentences belong together, verse 14 links the “bare rock” in verse 4 with the “place to spread fishnets” in verse 5, saying, “I will make you a bare rock, and you will become a place to spread fishnets.”

Almost as a footnote, Ezekiel then turns his attention toward the mainland, saying “...and her settlements on the mainland will be ravaged by the sword.” Also notice how Ezekiel refers to the island as Tyre, and the mainland as “settlements.”

“For this is what the Sovereign Lord says: From the north I am going to bring against Tyre Nebuchadnezzar king of Babylon, king of kings, with horses and chariots, with horsemen and a great army.”

Ezekiel accurately predicts that Nebuchadnezzar will come against Tyre, though an attempt on Tyre was highly probable. At the time of Ezekiel’s writing, he’d been exiled to Babylon and may have known about the king’s interest in Tyre (the attack happened soon after Ezekiel’s prediction). Ezekiel knew that Babylon had already conquered the Assyrians (612 BC), and was about to deal a final blow to Jerusalem (587 BC). He also knew Babylon was in the process of incorporating most of the Eastern Mediterranean. Tyre, with its wealth and strategic ports, would’ve been an obvious target, and Ezekiel’s promise of victory may have inspired Nebuchadnezzar (as we’ll see in a moment).

Ezekiel continues: “He will ravage your settlements on the mainland with the sword; he will set up siege works against you, build a ramp up to your walls and raise his shields against you. He will direct the blows of his battering rams against your walls and demolish your towers with his weapons” (v.8-9).

Here, God plainly states, “I am going to bring against Tyre Nebuchadnezzar ... He will direct the blows of his battering rams against your walls and demolish your towers with his weapons.”

We've already established that it is the *island's* walls and towers that are to be destroyed. But if that's the case, then this prophecy fails, because Nebuchadnezzar never breached the island walls.

The only option is to assume God has suddenly stopped talking about Nebuchadnezzar, and is now referring to the attack by Alexander the Great that would happen some 250 years later.

Continuing: "They will plunder your wealth and loot your merchandise; they will break down your walls and demolish your fine houses and throw your stones, timber and rubble into the sea. ¹³I will put an end to your noisy songs, and the music of your harps will be heard no more. ¹⁴I will make you a bare rock, and you will become a place to spread fishnets. **You will never be rebuilt, for I the Lord have spoken, declares the Sovereign Lord**" (v.12-14).

The final prophecy is that Tyre would never be rebuilt. Tyre was rebuilt, and still exists today. In fact, Tyre was even visited by Jesus himself.

So what happened?

Tyre was first destroyed on the mainland by Nebuchadnezzar, but the inhabitants simply retreated to the island offshore which they had prepared as a refuge when besieged. Alexander the Great would not put up with the taunting of the inhabitants of Tyre in their offshore refuge, and used the ruins of the mainland city that Nebuchadnezzar had destroyed to create a landbridge so the Greek army could besiege and destroy it, which they did. The final residue of the city of Tyre were completely destroyed by the Muslim invasion in the 7th century leaving the city completely uninhabitable. Today it is just a place that fishermen dry their nets as prophesied by Ezekiel 26:5 "*It shall be a place for the spreading of nets in the midst of the sea: for I have spoken it, saith the Lord GOD: and it shall become a spoil to the nations.*"

The fulfilling of this prophecy occurred in several phases. First, Babylon's Nebuchadnezzar warred against Tyre's mainland piece for 13 years (Ezekiel 26:7-11; 29:18). He was, however, robbed of the spoils of war when he overtook the city and found its riches and people had moved to Tyre's occupied island. Eventually the city made a peace agreement with Babylon. Babylon's king, however, fulfilled part of the prophecies of Ezekiel by destroying Tyre's mainland presence.

The prophecies against Tyre are remarkable in their fulfillment through centuries of invasions and conquest!

Cyrus and Jerusalem

Another incredible example of fulfilled prophecy is found in the book of Isaiah. The date of the book is fixed by its first verse: "The vision of Isaiah the son of Amoz, which he saw concerning Judah and Jerusalem in the days of Uzziah, Jotham, Ahaz, and

Hezekiah, kings of Judah.” Through history and archaeology, the dates of these kings are well known—from 767 to 686 B.C. Yet, in Isaiah 44, God revealed to Isaiah a coming conqueror who would permit Jerusalem to be rebuilt after its destruction—although in Isaiah’s day Jerusalem was still standing! So here is a prophecy so ahead of its time that only future generations in Jerusalem would first witness the city’s destruction and then its rebuilding!

Jerusalem was destroyed around 587 B.C. by the Babylonians some 100 years after Isaiah’s day. And work was not begun to reconstruct it until 539 B.C., when the prophesied king conquered Babylon and decreed that the captive Jews be freed and allowed to go back to Jerusalem to rebuild the city and the temple.

In Isaiah 44, God reveals to Isaiah the actual name of the coming conqueror who would allow Jerusalem to be rebuilt—Cyrus, known in history as Cyrus the Great. “Thus says the Lord, your Redeemer . . . : ‘I am the Lord, who makes all things, who stretches out the heavens all alone . . . who frustrates the signs of the babblers, and drives diviners mad . . . who says to Jerusalem, ‘You shall be inhabited,’ . . . who says of Cyrus, ‘He is My shepherd, and he shall perform all My pleasure, saying to Jerusalem, ‘You shall be built,’ and to the temple, ‘Your foundation shall be laid’”’” (Isaiah 44:24-28).

This is only one of the hundreds of Bible prophecies that have been confirmed. Dozens of specific prophecies deal with Jesus Christ and were fulfilled in precise detail. Again, no other ancient and supposedly sacred book even dares to present predictive prophecy—making the Bible unique. Its prophetic foretelling proves it is not the work of mere men.

Prophecy is the authentication given by God of his authorship of Scripture. No other holy book in the world has prophecy as the Bible. One out of every three verses is prophecy, some fulfilled and some future.

Daniel’s Prophecies

Daniel, in the period around 605-536 B.C., prophesied Greece would overtake the mighty Persians. Persia’s empire is considered the largest and most powerful of all ancient empires. Employing a goat to represent Greece, and a ram to symbolize Persia, Daniel wrote the following.

“I kept on watching and saw a goat come from the west and charge across the entire earth, without even touching the ground. Between his eyes was a powerful horn, and with tremendous anger the goat started toward the ram that I had seen beside the river. The goat was so fierce that its attack broke both horns of the ram, leaving him powerless. Then the goat stomped on the ram, and no one could do anything to help. After this, the goat became even more powerful. But at the peak of his power, his mighty horn was broken, and four other mighty horns took its place — one pointing to the north and one to the east, one to the south and one to the west” (Dan.8:5-8)..

Daniel is told, “The two horns of the ram are the kings of Media and Persia, the goat is the kingdom of Greece, and the powerful horn between his eyes is the first of its kings” (Daniel 8:20-21).

Some 200 years after the death of Daniel his God-inspired predictions proved correct. The undefeated Greek general Alexander the Great took the Persian empire around 334 - 330 B.C.

Messianic Prophecies

Of the many Biblical prophecies, the most striking examples are the predictions about an “anointed one” (“Messiah” in Hebrew) who was to arrive in the future. About 4 BC, a miraculous event occurred—a boy named Jesus was born to a *virgin* named Mary. You can read His story in the book of Luke.

Starting at age 30, Jesus fulfilled more and more of these prophecies written about the Messiah. His fulfillment of these prophecies was very spectacular: Jesus gave sight to the blind, made the lame walk, cured those who had leprosy, gave the deaf hearing, and raised people from the dead! These miracles and others were done many times in front of thousands of witnesses for three years.

About 30 AD, Jesus was crucified (a prophecy) and died (a prophecy). Three days later he rose from the dead (another prophecy), after which He was seen by over 500 witnesses. Since these prophecies were written down at least 400 years before they happened, there is no doubt that the Bible’s writers were inspired supernaturally—by God. To examine these prophecies yourself, read our articles, “The Astonishing Proof Jesus Is the Messiah” and “Daniel’s Prophecy Proves Christ Is the Messiah.”

Proof of Archaeology

Paul L. Maier wrote in *Christian Research Journal*, volume 27, number 2 (2004), that archaeological finds contradict the contentions of biblical minimalists and other revisionists. Among those that corroborate biblical evidence, and which provide the most significant discoveries are the following facts.

A Common Flood Story

Not just the Hebrews (Gen. 6–8), but Mesopotamians, Egyptians, and Greeks all report a flood in primordial times. A Sumerian king list from c. 2100 BC divides itself into two categories: those kings who ruled before a great flood and those who ruled after it. One of the earliest examples of Sumero-Akkadian-Babylonian literature, the Gilgamesh Epic, describes a great flood sent as punishment by the gods, with humanity saved only when the pious Utnapishtim (AKA, “the Mesopotamian Noah”) builds a ship and saves the animal world thereon. A later Greek counterpart, the story of Deucalion and Phyrra, tells of a couple who survived a great flood sent by an angry Zeus. Taking refuge

atop Mount Parnassus (AKA, “the Greek Ararat”), they supposedly repopulated the earth by heaving stones behind them that sprang into human beings.

The Code of Hammurabi

This seven-foot black diorite stele, discovered at Susa and presently located in the Louvre museum, contains 282 engraved laws of Babylonian King Hammurabi (fl. 1750 BC). The common basis for this law code is the *lex talionis* (“the law of the tooth”), showing that there was a common Semitic law of retribution in the ancient Near East, which is clearly reflected in the Pentateuch. Exodus 21:23–25, for example, reads: “But if there is serious injury, you are to take life for life, eye for eye, tooth for tooth, hand for hand, foot for foot...” (NIV).

The Nuzi Tablets

The some 20,000 cuneiform clay tablets discovered at the ruins of Nuzi, east of the Tigris River and datable to c. 1500 BC, reveal institutions, practices, and customs remarkably congruent to those found in Genesis. These tablets include treaties, marriage arrangements, rules regarding inheritance, adoption, and the like.

The Existence of Hittites

Genesis 23 reports that Abraham buried Sarah in the Cave of Machpelah, which he purchased from Ephron the Hittite. Second Samuel 11 tells of David’s adultery with Bathsheba, the wife of Uriah the Hittite. A century ago the Hittites were unknown outside of the Old Testament, and critics claimed that they were a figment of biblical imagination. In 1906, however, archaeologists digging east of Ankara, Turkey, discovered the ruins of Hattusas, the ancient Hittite capital at what is today called Boghazkoy, as well as its vast collection of Hittite historical records, which showed an empire flourishing in the mid-second millennium BC. This critical challenge, among many others, was immediately proved worthless — a pattern that would often be repeated in the decades to come.

The Merneptah Stele

A seven-foot slab engraved with hieroglyphics, also called the Israel Stele, boasts of the Egyptian pharaoh’s conquest of Libyans and peoples in Palestine, including the Israelites: “Israel — his seed is not.” This is the earliest reference to Israel in nonbiblical sources and demonstrates that, as of c. 1230 BC, the Hebrews were already living in the Promised Land.

Biblical Cities Attested Archaeologically

In addition to Jericho, places such as Haran, Hazor, Dan, Megiddo, Shechem, Samaria, Shiloh, Gezer, Gibeah, Beth Shemesh, Beth Shean, Beersheba, Lachish, and many other urban sites have been excavated, quite apart from such larger and obvious

locations as Jerusalem or Babylon. Such geographical markers are extremely significant in demonstrating that *fact*, not *fantasy*, is intended in the Old Testament historical narratives; otherwise, the specificity regarding these urban sites would have been replaced by “Once upon a time” narratives with only hazy geographical parameters, if any.

Israel’s enemies in the Hebrew Bible likewise are not contrived but solidly historical. Among the most dangerous of these were the Philistines, the people after whom Palestine itself would be named. Their earliest depiction is on the Temple of Rameses III at Thebes, c. 1150 BC, as “peoples of the sea” who invaded the Delta area and later the coastal plain of Canaan. The Pentapolis (five cities) they established — namely Ashkelon, Ashdod, Gaza, Gath, and Ekron — have all been excavated, at least in part, and some remain cities to this day. Such precise urban evidence measures favorably when compared with the geographical sites *claimed* in the holy books of other religious systems, which often have no basis whatever in reality.¹⁰

Shishak’s Invasion of Judah

First Kings 14 and 2 Chronicles 12 tell of Pharaoh Shishak’s conquest of Judah in the fifth year of the reign of King Rehoboam, the brainless son of Solomon, and how Solomon’s temple in Jerusalem was robbed of its treasures on that occasion. This victory is also commemorated in hieroglyphic wall carvings on the Temple of Amon at Thebes.

The Moabite Stone

Second Kings 3 reports that Mesha, the king of Moab, rebelled against the king of Israel following the death of Ahab. A three-foot stone slab, also called the Mesha Stele, confirms the revolt by claiming triumph over Ahab’s family, c. 850 BC, and that Israel had “perished forever.”

Obelisk of Shalmaneser III

In 2 Kings 9–10, Jehu is mentioned as King of Israel (841–814 BC). That the growing power of Assyria was already encroaching on the northern kings prior to their ultimate conquest in 722 BC is demonstrated by a six-and-a-half-foot black obelisk discovered in the ruins of the palace at Nimrud in 1846. On it, Jehu is shown kneeling before Shalmaneser III and offering tribute to the Assyrian king, the only relief we have to date of a Hebrew monarch.

Burial Plaque of King Uzziah

Down in Judah, King Uzziah ruled from 792 to 740 BC, a contemporary of Amos, Hosea, and Isaiah. Like Solomon, he began well and ended badly. In 2 Chronicles 26 his sin is recorded, which resulted in his being struck with leprosy later in life. When Uzziah died, he was interred in a “field of burial that belonged to the kings.” His stone burial

plaque has been discovered on the Mount of Olives, and it reads: “Here, the bones of Uzziah, King of Judah, were brought. Do not open.”

Hezekiah’s Siloam Tunnel Inscription

King Hezekiah of Judah ruled from 721 to 686 BC. Fearing a siege by the Assyrian king, Sennacherib, Hezekiah preserved Jerusalem’s water supply by cutting a tunnel through 1,750 feet of solid rock from the Gihon Spring to the Pool of Siloam inside the city walls (2 Kings 20; 2 Chron. 32). At the Siloam end of the tunnel, an inscription, presently in the archaeological museum at Istanbul, Turkey, celebrates this remarkable accomplishment. The tunnel is probably the only biblical site that has not changed its appearance in 2,700 years.

The Sennacherib Prism

After having conquered the 10 northern tribes of Israel, the Assyrians moved southward to do the same to Judah (2 Kings 18–19). The prophet Isaiah, however, told Hezekiah that God would protect Judah and Jerusalem against Sennacherib (2 Chron. 32; Isa. 36–37). Assyrian records virtually confirm this. The cuneiform on a hexagonal, 15-inch baked clay prism found at the Assyrian capital of Nineveh describes Sennacherib’s invasion of Judah in 701 BC in which it claims that the Assyrian king shut Hezekiah inside Jerusalem “like a caged bird.” Like the biblical record, however, it does *not* state that he conquered Jerusalem, which the prism certainly would have done had this been the case. The Assyrians, in fact, bypassed Jerusalem on their way to Egypt, and the city would not fall until the time of Nebuchadnezzar and the Neo-Babylonians in 586 BC. Sennacherib himself returned to Nineveh where his own sons murdered him.

The Cylinder of Cyrus the Great

Second Chronicles 36:23 and Ezra 1 report that Cyrus the Great of Persia, after conquering Babylon, permitted Jews in the Babylonian Captivity to return to their homeland. Isaiah had even prophesied this (Isa. 44:28). This tolerant policy of the founder of the Persian Empire is borne out by the discovery of a nine-inch clay cylinder found at Babylon from the time of its conquest, 539 BC, which reports Cyrus’s victory and his subsequent policy of permitting Babylonian captives to return to their homes and even rebuild their temples.

Maier concludes: “So it goes. This list of correlations between Old Testament texts and the hard evidence of Near Eastern archaeology could easily be tripled in length. When it comes to the intertestamental and New Testament eras, as we might expect, the needle on the gauge of positive correlations simply goes off the scale.”

The Proof of Textual Evidence

Both the Old and New Testaments are strongly supported by manuscript evidence (the evidence of early hand written copies). The famous Dead Sea Scrolls are one

example of the Old Testament evidence. These documents came from the “library” of a settlement founded at Qumran before 150 B.C. and abandoned about 68 A.D. Some of the manuscript copies were made during that period, and some were written earlier (third century BC) and brought to the settlement. Ignoring spelling-oriented (orthographic) changes and similar small differences, the Dead Sea Scrolls match the Hebrew text behind today’s Old Testament, in spite of the passage of over 2,000 years (where one would expect errors to creep in).

Over 20,000 known manuscripts document the New Testament text. This makes the New Testament the most reliable document of antiquity (a document written before the printing press). These manuscripts vary in size from a part of a page to an entire Bible (Old and New Testaments). The earliest New Testament manuscripts date from the second century (100-199) AD. These manuscript copies were written in different languages by people of different nationalities, cultures, and backgrounds. In spite of all those differences between them, the New Testament texts all agree. (That is, those differences that we do observe between these hand written documents are occasional changes in the spelling of names or isolated cases of missing or changed words. Still, since we have so many copies, it is obvious to anyone but the hardened skeptic that they all represent the same text.)

Note: Those minor differences that do exist between the Old and New Testament manuscripts are interesting for academic reasons. They are the topic of a future in depth “Clarifying Christianity” study.

Evidence of Jesus Christ

Secular history supports the Bible and the historicity of Christ. For example, in *The Antiquities of the Jews*, book 18, chapter 3, paragraph 3 the famous historian Flavius Josephus writes:

“Now, there was about this time Jesus, a wise man, if it be lawful to call him a man, for he was a doer of wonderful works – a teacher of such men as receive the truth with pleasure. He drew over to him both many of the Jews, and many of the Gentiles. He was [the] Christ; and when Pilate, at the suggestion of the principal men amongst us, had condemned him to the cross, those that loved him at the first did not forsake him, for he appeared to them alive again the third day, as the divine prophets had foretold these and ten thousand other wonderful things concerning him; and the tribe of Christians, so named from him, are not extinct at this day.”

In 115 AD, P. Cornelius Tacitus wrote the following passage that refers to Jesus (called “Christus,” which means “The Messiah”) in book 15, chapter 44 of *The Annals*:

“Consequently, to get rid of the report, Nero fastened the guilt and inflicted the most exquisite tortures on a class hated for their abominations, called Christians by the populace. Christus, from whom the name had its origin, suffered the extreme penalty during the reign of Tiberius at the hands of one of our procurators, Pontius Pilatus, and a

most mischievous superstition, thus checked for the moment, again broke out not only in Judaea, the first source of the evil, but even in Rome, where all things hideous and shameful from every part of the world find their centre and become popular.

“Accordingly, an arrest was first made of all who pleaded guilty; then, upon their information, an immense multitude was convicted, not so much of the crime of firing the city, as of hatred against mankind. Mockery of every sort was added to their deaths. Covered with the skins of beasts, they were torn by dogs and perished, or were nailed to crosses, or were doomed to the flames and burnt, to serve as a nightly illumination, when daylight had expired.”

Tacitus’s terse statement about “Christus” clearly corroborates the New Testament on certain historical details of Jesus’ death. Tacitus presents four pieces of accurate knowledge about Jesus: (1) *Christus*, used by Tacitus to refer to Jesus, was one distinctive way by which some referred to him, even though Tacitus mistakenly took it for a personal name rather than an epithet or title; (2) this *Christus* was associated with the beginning of the movement of Christians, whose name originated from his; (3) he was executed by the Roman governor of Judea; and (4) the time of his death was during Pontius Pilate’s governorship of Judea, during the reign of Tiberius.

Other strong evidence that speaks directly about Jesus as a real person comes from Josephus, a Jewish priest who grew up as an aristocrat in first-century Palestine and ended up living in Rome, supported by the patronage of three successive emperors. In the early days of the first Jewish Revolt against Rome (66–70 C.E.),

Josephus was a commander in Galilee but soon surrendered and became a prisoner of war. He then prophesied that his conqueror, the Roman commander Vespasian, would become emperor, and when this actually happened, Vespasian freed him. From then on Josephus lived in Rome under the protection of the Flavians and there composed his historical writings.

In his two great works, *The Jewish War* and *Jewish Antiquities*, both written in Greek for educated people, Josephus tried to appeal to aristocrats in the Roman world, presenting Judaism as a religion to be admired for its moral and philosophical depth. *The Jewish War* doesn’t mention Jesus except in some versions in likely later additions by others, but *Jewish Antiquities* does mention Jesus—twice.

The shorter of these two references to Jesus (in Book 20)¹¹ is incidental to identifying Jesus’ brother James,¹² the leader of the church in Jerusalem. In the temporary absence of a Roman governor between Festus’s death and governor Albinus’s arrival in 62 C.E., the high priest Ananus instigated James’s execution. Josephus described it: “Being therefore this kind of person [i.e., a heartless Sadducee], Ananus, thinking that he had a favorable opportunity because Festus had died and Albinus was still on his way, called a meeting [literally, “sanhedrin”] of judges and brought into it the brother of Jesus-

who-is-called-Messiah ... James by name, and some others. He made the accusation that they had transgressed the law, and he handed them over to be stoned.”

James is otherwise a barely noticed, minor figure in Josephus’s lengthy tome. The sole reason for referring to James at all was that his death resulted in Ananus losing his position as high priest. James (Jacob) was a common Jewish name at this time. Many men named James are mentioned in Josephus’s works, so Josephus needed to specify which one he meant. The common custom of simply giving the father’s name (James, son of Joseph) would not work here, because James’s father’s name was also very common. Therefore Josephus identified this James by reference to his famous brother Jesus.

But James’s brother Jesus (Yehoshua) also had a very common name. Josephus mentions at least 12 other men named Jesus. Therefore Josephus specified *which* Jesus he was referring to by adding the phrase “who is called Messiah,” or, since he was writing in Greek, *Christos*. This phrase was necessary to identify clearly first Jesus and, via Jesus, James, the subject of the discussion. This extraneous reference to Jesus would have made no sense if Jesus had not been a real person.

Is the Bible Inspired by God?

For many centuries agnostics, skeptics and scoffers have called the Bible a collection of ancient primitive myths, fables, stories, and superstition. One religious leader calmly claimed, “We know now that every idea in the Bible started from primitive and childlike origins”

Even Dr. Edgar J. Goodspeed, who translated the Bible into English, declared that the book of Joshua “is the legendary story of the conquest of Canaan” and claimed that the book of Ruth “belongs to Israel’s fiction, rather than to its history, and should be among its tales and stories.”

Why so much disrespect for the Bible? Why have so-many men of high education, scholars, and scientists and even ministers REJECTED the Bible as reliable historical truth?

Surprisingly enough, even many modern ministers publicly declare the Bible is not inspired by a Creator God. Harry Emerson Fosdick, a noted American minister, wrote, “We know now that every idea in the Bible started from *primitive* and childlike origins” (*The Modern Use of the Bible*, p.11). He spoke of certain “crudities” in the earlier writings in the Bible and said, “Their lack is a lack of maturity.”

Dr. Edgar J. Goodspeed, who translated the Bible into English, said of the first twelve books in the Bible, “It is man’s first attempt to organize his knowledge of his past into what we would call an outline of history. Genesis,” he wrote, “is a great encyclopedia of *Hebrew* thought” -- NOT divine revelation from Almighty *GOD!*

The book of Joshua, he says, “is the *legendary story* of the conquest of Canaan.”

The book of Ruth, he believes, "belongs to Israel's *fiction*, rather than to its history, and should be among its *tales and stories*" (*How to Read the Bible*, p. 39, 51).

THESE are the words of ministers translators, and Bible scholars! They should not be taken lightly. They are the opinions of the vast, overwhelming majority of Biblical scholars and critics. Why do such people generally believe the Bible is merely a grouping of stories, legends and myths?

There is a REASON!

Most professors and scholars are unwilling to admit the divine inspiration of the Bible because *they are BLINDED to the truth!* Human nature tends to resist "authority" of any kind. For a human being to admit to the authority of a God, and His divinely inspired Word, they would then be in a very awkward position if they continued to criticize His Word and its contents.

If they accepted its divine origin as to contents and inspiration, then they would have to recognize its **AUTHORITY** over their lives – they would be obligated to *OBEY it!*

How many men do you know who really want to obey the Ten Commandments? Who deep down really desire to obey ALL the laws and commandments of the God of the Bible?

However, the Bible speaks with AUTHORITY and it was divinely inspired. Jesus Christ said, "The Scripture cannot be broken" (John 10:35). The apostle Paul wrote, "ALL SCRIPTURE is given by inspiration of God, and is profitable for doctrine, for reproof, for correction, for instruction in righteousness: that the man of God may be perfect, throughly furnished unto all good works " (II Tim.3:16-17). Christ also said, "You shall know the truth, and the truth shall make you free" (Jon 8:32).

Isn't it about time we re-open the Bible, blow the dust off its pages, and read it with renewed respect and serious, sober-minded attention?

The day is coming when we shall all be JUDGED by its contents.

"And I saw the dead, small and great stand before God; and the books [biblia] were opened: and another book was opened, which is the book of life: and the dead were *judged* out of those things which were written in the books, according to their works" (Re.20:12-13).

Again, God says, "*Study* to show thyself approved unto God, a workman that needeth not to be ashamed, rightly dividing the *word of truth*" (II Tim.2:15).

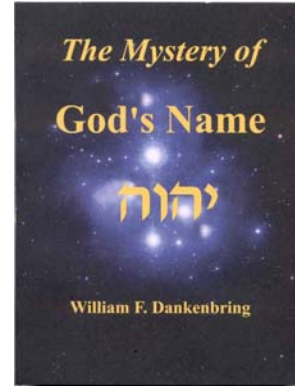
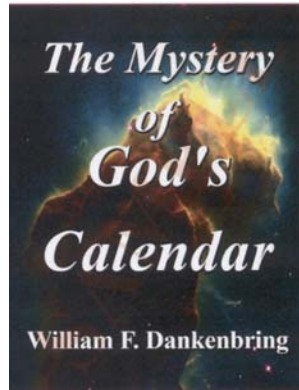
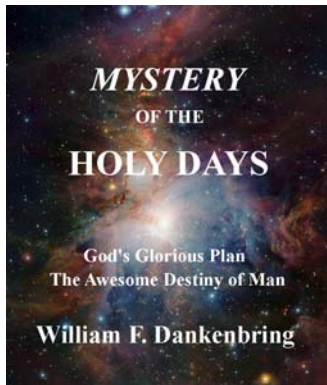
